Human Services for Success			
Accessible Resources for Independence	\$ 25,000.00	\$ 14,970.75	Funds were used to support Accessible Resources for Independence to attend, host, and/or co-host over 20 community events for Meade Village Residents to provide information and referral services for preventative healthcare, youth self-advocacy, mental health services, etc. Through this outreach, they were able to develop/launch a Workplace Readiness Series for adults with disabilities to be launched during Summer 2022. They requested an extension through December 2022 that was granted.
Anne Arundel County Food Bank	\$ 40,000.00	\$ -	Funds were used to support the Anne Arundel County Food Bank's Family Choice Farmer's Market at Van Bokkelen Elementary School during Spring 2022. The Farmer's Market provided free, fresh, and healthy produce to 431 local families and 1,762 individuals.
Boys & Girls Clubs of Annapolis and Anne Arundel County	\$ 55,000.00	\$ -	Funds were used to support the Boys & Girls Club at Meade Village, which provided services to 361 students from surrounding communities, to engage them in safe and educational activities. Supports include homework help, tutoring, and teaching money management and STEM material. Additionally, programs such as "Teen Night" were held to facilitate and encourage peer-to-peer socialization, engage students in fun age-appropriate activities.
BWI Community Development Foundation, Inc.- County Connector Shuttle	\$ 588,000.00	\$ 40,655.17	Funds were used to continue BWI's County Connector Shuttle, connecting residents, workforce, and job-seekers to recreation and employment opportunities in and around Live! Casino & Hotel, Arundel Mills Mall, BWI Marshall Airport, and the BWI MARC/Amtrak Station. This transit service is fare-free and operates 365 days a year, weather permitting. This year, BWI provided rides for over 70,000 passengers.

Organization	Award	Funds Remaining	Accomplishments
Caring Cupboard	\$ 20,000.00	\$ -	Funds were used to support periodic pop-up pantries at Meade Middle School and Jessup Baptist Church, as well as home delivery of goods to families that lack reliable transportation or have been impacted by COVID-19. Families were provided with perishable and non-perishable food, as well as personal hygiene items. In FY22, Caring Cupboard served 1,165 households and 3,020 individuals with food and hygiene essentials.
Christian Assistance Program	\$ 25,000.00	\$ -	Funds were used to continue CAP's Weis Market voucher program, which provided store vouchers to residents of the LDC target area to purchase fresh milk, and other dairy items once per month to supplement the non-perishable food items provided at the CAP pantry distributions. During FY22, CAP served 196 households and 725 individuals.
Chrysalis House	\$ 400,000.00	\$ -	Funds were used to support the Chrysalis House Campus Expansion Project. While the project is not yet completed, LDC funds were expended in the early stages of construction to support the clinical wing, with flooring and HVAC completed, childcare wing modifications complete, and painting, walkways, and flooring for the second floor still needed. Construction is expected to be completed by end of 2022.
Complete Player Charity	\$ 25,000.00	\$ -	Funds were used to support The Complete Player Charity's after-school Youth Empowerment programming for 23 students attending Meade and MacArthur Middle Schools and Meade High School throughout the 2021-2022 school year. Activities included creating vision boards, programming around marketing, accounting and business fundamentals, and the development and implementation of community events. This year, students developed business plans, improved their grades, and did a community clean up project in collaboration with BWI Community Development Foundation.

Fort Meade Alliance Resiliency Center	\$ 250,000.00	\$ 120,396.84	Funds were used to fill a gap in funding for the new Resiliency and Education Center on Fort Meade, which will help soldiers, veterans, Department of Defense civilians and their families connect to resources and empower them to be the best that they can be. To date, construction is more than 70% complete and the majority of prior year and current year LDC funds have been drawn. Specifically, LDC funds have been used to support design services; site cleaning; asbestos abatement; demolition and mold removal; cabinetry materials; doors and hardware; framing, carpentry, insulation, attic plywood, structural modifications, and drywall; drawing and engineer work for elevators; fire safety systems; plumbing, HVAC, and gas piping; electrical; roofing; windows; flooring materials.
Hope for All, Inc.	\$ 40,000.00	\$ 8,009.25	Funds supported HOPE for All's Turning Houses into Homes Program, which provided over 220 pieces of furniture to 34 households within the 3-mile radius of Live! Casino. Many of the 34 households were led by single female heads of household who were moving into permanent housing after being homeless. An extension through December 2022 was granted.
Housing Commission of Anne Arundel County	\$ 30,000.00	\$ -	Funds supported HCAAC's partnership with the Tunnel Vision "Chase Your Dreams Initiative," which supported Meade Village public housing residents through sporting events, travel outings, and twice-monthly listening sessions to promote a sense of community and connect residents in need with necessary resources. In FY22, HCAAC served over 1,000 individuals.
Kingdom Kare - Mentoring Program	\$ 40,000.00	\$ -	Funds were used to support Kingdom Kare's mentoring program, which served 26 at risk school-aged children attending Meade High School. They gave students a safe space to complete their classwork and allow them to intern in their Child Development Center to prepare them to work in the childcare field. Female students were paired with a mentor and were walked through the registration process at the local community college. This year, several of the participants that were graduating were hired by Kingdom Kare to work in the Child Development Center.

Organization	Award	Funds Remaining	Accomplishments
Maryland Reentry Resource Center	\$ 36,100.00	\$ -	Funds supported Maryland Reentry's Reentry Management Services Program, which provided wraparound case management services to 116 individuals exiting incarceration, and at-risk youth in the Meade Village area, as well as a back to school event during Q1 where backpacks, school supplies, toiletries, household goods, and fresh produce were distributed. Funding was used for staff costs, direct client assistance, stipends for returning individuals to participate in transitional employment and operating expenses.
Partners in Care	\$ 25,000.00	\$ -	Funds supported Partners in Care's programs for seniors residing in the LDC's target area. Partners in Care provided services to 92 individuals by providing transportation (such as ride sharing), member care, and handyman services to older adults in the area.
Sarah's House	\$ 80,000.00	\$ -	Funds supported a Case Management Specialist and a Child Care Specialist at Sarah's House. As a result of the grant funds, 401 clients (196 adults and 205 children) were provided with intensive case management and childcare services in the Sarah's House shelter program. These services assisted adults to obtain employment, increase their income, and, in some cases, exit permanent supportive housing and re-enter the community.
Severn Center	\$ 2,000,000.00	\$ 1,523,723.24	Funds were used to support the construction of the new Severn Center which will include a new state of the art Boys & Girls Club and gym, Senior Activity Center and flexible community space. Construction is approximately 64% complete.

The Arc of the Central Chesapeake	\$ 30,000.00	\$ -	Funds supported the renovated of the Arc's community hub bathroom to include a mounted and motorized adult changing table, and motorized toilet lift with bidet function to allow use to people with significant physical disabilities.
YWCA	\$ 20,000.00	\$ 20,000.00	Grantee denied their FY22 award due to delays in implementing the project, and their full award was recaptured. Funds will be re-allocated to future projects.
Enhancing Educational Outcomes			
Annapolis Maritime Museum	\$ 40,000.00	\$ -	Funds were used to support Annapolis Maritime Museum's Oyster Education Program and Box of Rain Summer Program, which served over 600 students from Meade and MacArthur Middle Schools throughout the 2021-2022 school year and into the summer. Activities included building model kits of oysters, participating in an interview with a local waterman, virtually touring an historic skipjack, and witnessing oyster planting on a local sanctuary in the Severn River.

Assistance League of the Chesapeake, Inc.	\$ 35,000.00	\$ -	Funds were used to support The Assistance League of the Chesapeake's Operation School Bell Kids in Need program, which served over 1,000 school-aged children at Meade Heights and Van Bokkelen Elementary schools with new uniforms and books.
Junior Achievement of Central Maryland	\$ 20,000.00	\$ 20,000.00	Unfortunately, programming was unable to get started due to difficulty in getting into schools with new stressors placed on teachers/school administrators during COVID, therefore funding is being recaptured and will be re-allocated to future projects.
Kingdom Kare - Family Support Center	\$ 91,884.00	\$ -	Funds were used to support Kingdom Kare's new Family Support Center, which served 29 teen mothers and their children by providing free daycare while the teen moms worked on completing their school work to earn their high school diplomas through Anne Arundel County Public Schools. Ongoing case management was provided to support the mothers' well being as well as the the mothers to support the well-being of both mother and child.

Rob's Community Barbershop Foundation	\$ 25,000.00	\$ 7,325.11	Funds were used to support Rob's Barbershop's programming at MacArthur Middle School, which taught 34 students how to do their hair while providing free grooming services to them at the same time. There was some difficulty in getting the programming off the ground at the beginning of the school year given new COVID measures, so the grant was extended to the end of the calendar year.
Severn Elementary School PTSA	\$ 32,000.00	\$ 941.29	Funds were used to install a new digital LED marquee sign in front of Severn Elementary.
STAIR	\$ 20,000.00	-	Funds were used to support 12 second graders reading below grade level at Severn Elementary School improve their literacy, increase their sense of self-esteem and self-confidence, and provide them with a caring environment where reading is fun.

BWI Community Development Foundation, Inc.-Beautification	\$ 440,000.00	\$ 14,522.00	Funds were used to provide beautification services in the area surrounding Live! Casino, including litter pick up, large debris removal, flower bed maintenance and planting, tree trimming, bush pruning, weed control and grass cutting. More than 5000 bags of litter, trash and debris were collected from the designated areas during FY22.
Jessup Improvement Association	\$ 97,744.00	\$ 64,233.86	Funds were used to make renovations to the Jessup Community Hall. These renovations began during this fiscal year, with parking lot striping, french drain install, tree removals and material costs for digital sign and kitchen equipment incurred. This project remains in progress, with an estimated completion date of December 2022.
Hawks Ridge HoA	\$ 11,500.00	\$ 346.00	Funds were used to complete multiple landscaping improvements and plantings throughout the Hawks Ridge community, including street trees. The final quote was lower than the original, so there was a small amount of savings.
Severn Crest HoA	\$ 10,400.00	\$ -	Funds were used for the grading and permitting costs related to implementing the solution to storm water runoff issues that was identified through a previous engineering study, funded with LDC funds. During FY22, Severn Crest was able to complete a grading plan and permitting for storm water corrections and anticipates applying for additional funding this year.

Organization	Award	Funds Remaining	Accomplishments
Spring Meadows - Roof Replacement Phase III	\$ 420,000.00	\$ 377,826.52	Funds were used to support Phase III of the Spring Meadows Roof Replacement project. During FY22, Phase II was completed, which resulted in a total of 59 units completed and Phase III got underway. The contractor is currently implementing Phase III, which is approximately 75% complete and has an anticipated completion of November 2022.
Stillmeadows Condo Association	\$ 40,000.00	\$ 36,250.00	Funds were awarded to complete a community wide needs assessment and to contribute to the recommended improvements that resulted from that needs assessment. The needs assessment was completed and identified repaving of the parking lots as the priority need, but this is a project that will require additional funding. Stillmeadows hopes to apply for additional funding in FY24 to fill the gap.
Watershed Stewards Academy	\$ 60,000.00	\$ 60,000.00	Funds were awarded for The Watershed Stewards Academy to collaborate with St. Mark's United Methodist Church to develop a new stormwater management system to direct waterflow away from the church's parking lot, alleviate flooding and help improve the health of the waterways. A previous VLT grant paid for the design and engineering services. While no FY 22 funds have been expended to date, these funds allowed Watershed Stewards Academy to fill a funding gap for the \$300,000 proposed project. There were some reported delays with permitting and they are currently finalizing contractor procurement before work begins.
