In accordance with Article 11 of the Anne Arundel County Code, a Class FA license is required for a single location or single room of a building in which are located twenty (20) or more coin operated amusement devices. A Class FA license may be issued only to the owner or operator of the location or room of a building in which the coin-operated amusement devices are located. The annual license fee is \$5,000. The license term runs from July 1 through June 30 each year. Applications received after June 30 are subject to a late fee of \$100 per day.
