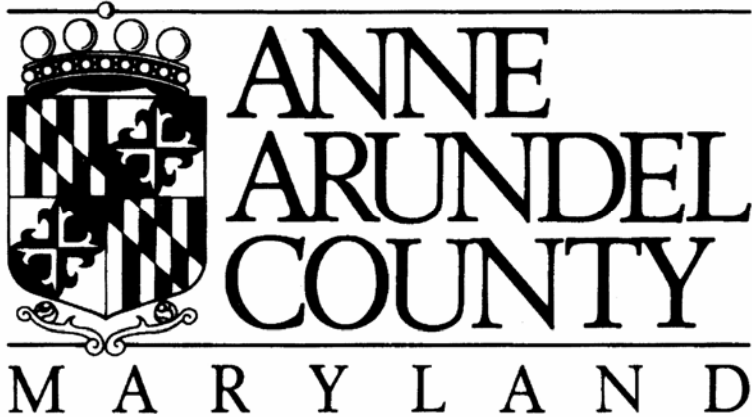

These loan proceeds will be disbursed to Arundel Community Development Services, Inc. for loan to the Boys and Girls Club of Annapolis and Anne Arundel County. Repayment of the funds borrowed by the County will be guaranteed by a pledge of future CDBG revenues.
