The Work includes the following major items: Removal of existing circulation and/or information desk at three separate locations, removal of existing light fixtures as noted, relocation of existing water fountain, removal of existing feature wall, installation of new desk including electrical and telephone hookups, installation of new light fixtures, patch repair existing ceiling, patch existing concrete floor as indicated in the plans, specifications, and other contract documents contained in the LR08 - SERVICE DESK UPGRADES - LIBRARIES package.
