A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Cell 9 Disposal Area – Fund  
2 Transfer

3  
4 FOR the purpose of amending the Capital Budget by transferring an appropriation of funds  
5 from the Cell 8 Disposal Area capital project to the Cell 9 Disposal Area capital project;  
6 and amending the Capital Program and Capital Projects Bond Ordinance.

8 BY amending: Capital Budget  
9 Capital Program  
10 Capital Projects Bond Ordinance

12 WHEREAS, Section 716 of the Charter authorizes the County Council, upon request  
13 of the County Executive and by the affirmative vote of five members of the County  
14 Council, to amend the capital budget; and

15  
16 WHEREAS, Section 711(b) of the Charter authorizes the County Council, upon  
17 request of the County Executive, to transfer appropriations between capital projects  
18 in the Capital Budget; and

20 WHEREAS, the capital project, Cell 9 8 Disposal Area, Project No. ~~N530600~~  
21 N465500, has an existing appropriation; and

1 WHEREAS, the County Executive is requesting that \$275,000 be transferred from  
2 the Cell 8 Disposal Area capital project, Project No. N465500, to the Cell 9 Disposal  
3 Area, Project No. N530600; and

5 WHEREAS, in accordance with Section 716 of the Charter, the County Executive  
6 and the Planning Advisory Board have recommended amendments to the Capital  
7 Budget; now, therefore,  
8

9 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
10 That the Capital Budget for the fiscal year ending June 30, 2007, is hereby amended by  
11 transferring an appropriation of funds in the total amount of \$275,000 from Cell 8 Disposal  
12 Area, Project No. N465500 (Solid Waste Bonds) to Cell 9 Disposal Area, Project No.  
13 N530600 (Solid Waste Bonds).

15 SECTION 2. *And be it further enacted,* That the Capital Program and the Capital Project  
16 Bonds Ordinance for the fiscal year ending June 30, 2007, are hereby amended in  
17 accordance with the provisions of this Ordinance.  
18

19 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days  
20 from the date it becomes law.
