A BILL ENTITLED

1 AN EMERGENCY ORDINANCE concerning: Current Expense Budget – Transfer of Funds
2 – Chief Administrative Officer – Reserve for Contingencies – Workforce Development
3 Corporation
4

5 FOR the purpose of transferring an appropriation of funds from the Chief Administrative
6 Officer, Reserve for Contingencies, to the Chief Administrative Officer, Workforce
7 Development Corporation; and making this Ordinance an emergency measure.
8

9 BY amending: Current Expense Budget
10

11 WHEREAS, under Section 711(a) of the Charter, upon recommendation of the
12 County Executive, the County Council may transfer funds between offices,
13 departments, institutions, boards, commissions or other agencies of the County
14 government and within the same fund of the Current Expense Budget; and
15

16 WHEREAS, under Section 711(a) of the Charter, the County Executive may
17 authorize transfers of funds from within the same department and within the same
18 fund; and
19

20 WHEREAS, under § 712 of the Charter, upon recommendation of the County
21 Executive, the County Council may make supplementary appropriations from
22 contingent funds, provided that the Controller shall first certify in writing that such
23 funds are available for such appropriation; and

24 WHEREAS, the County Executive has made a recommendation that funds from the

1 FY2009 appropriation to Chief Administrative Officer, Reserve for Contingencies,
2 be transferred to the Chief Administrative Officer, Workforce Development
3 Corporation; and

5 WHEREAS, the Controller has certified in writing that such funds are available for
6 appropriation; now, therefore,
7

8 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
9 That the Current Expense Budget for the fiscal year ending June 30, 2009, be and it is hereby
10 amended by transferring the appropriation of funds from Chief Administrative Office -
11 General Fund Appropriation, Reserve for Contingencies, in the amount of \$125,000 to the
12 Chief Administrative Office - General Fund Appropriation, Workforce Development
13 Corporation.

15 SECTION 2. *And be it further enacted,* That this Ordinance is hereby declared to be an
16 emergency ordinance and necessary for the immediate preservation of the public peace,
17 health, safety, welfare, and property and being passed by the affirmative vote of five
18 members of the County Council, the same shall take effect from the date it becomes law.
