A BILL ENTITLED

1 AN EMERGENCY ORDINANCE concerning: Capital Budget and Program – Holland
2 Point SECD – Additional Appropriation

3
4 FOR the purpose of amending the Capital Budget by making an additional appropriation
5 of funds to the Holland Point SECD capital project; amending the Capital Program
6 and Capital Projects Bond Ordinance; and making this Ordinance an emergency
7 measure.

9 BY amending: Capital Budget

13 WHEREAS, the capital project, Holland Point SECD, Project No. Q537200, has
14 an existing appropriation in the Capital Budget for fiscal year ending June 30,
15 2009, and additional funding of \$148,840 in loan funds and technical and
16 administrative services has become available from the Maryland Department of
17 Natural Resources, which was not anticipated in budget estimates for fiscal year
18 2009; and

20 WHEREAS, Sections 712 and 716 of the Charter authorize the County Council,
21 upon request of the County Executive and by affirmative vote of five members of
22 the County Council, to amend the capital budget to increase the total amount of
23 appropriations to the capital budget from revenues from sources anticipated in the
24 budget but in excess of budget estimates for the current fiscal year; and

1 WHEREAS, the County Executive is requesting that \$148,840 in loan funds and
2 technical and administrative services from the Maryland Department of Natural
3 Resources be appropriated to the capital project, Holland Point SECD, Project
4 No. Q537200; and

6 WHEREAS, in accordance with Section 716 of the Charter, the County Executive
7 and the Planning Advisory Board have recommended amendments to the Capital
8 Budget; and
9

10 WHEREAS, the Controller has certified in writing that such funds are available
11 for appropriation; and
12

13 WHEREAS, Section 307(i) of the Charter authorizes the County Council to
14 increase the funding for a capital project by emergency ordinance so long as the
15 increase is required solely to meet cost escalation and does not affect the scope of
16 the project, and the County Council has determined that this increase in funding
17 complies with this requirement of the Charter; now, therefore,
18

19 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
20 *Maryland,* That the Capital Budget for the fiscal year ending June 30, 2009, is hereby
21 amended by making an additional appropriation in the amount of \$148,840 from the
22 Maryland Department of Natural Resources, which was not anticipated in the budget
23 estimates for fiscal year 2009, to the Holland Point SECD, Project No. Q537200.

25 SECTION 2. *And be it further enacted,* That the Capital Program and Capital Projects
26 Bond Ordinance for the fiscal year ending June 30, 2009, are hereby amended in
27 accordance with the provisions of this Ordinance.

29 SECTION 3. *And be it further enacted,* That this Ordinance is hereby declared to be
30 an emergency ordinance and necessary for the immediate preservation of the public
31 peace, health, safety, welfare, and property, and being passed by the affirmative vote of
32 five members of the County Council, the same shall take effect from the date it becomes
33 law.
