1 AN ORDINANCE concerning: Video Lottery Facility Local Development Council

3 FOR the purpose of establishing a Video Lottery Facility Local Development Council;  
4 providing for the composition, time of appointment, and powers and duties of the  
5 Council; and generally relating to a Video Lottery Facility Local Development Council.

7 BY renumbering: §§ 3-13-101 through 3-13-103 and the title “Title 13. Workforce  
8 Development” to be §§ 3-14-101 through 3-14-103 and the title “Title 14. Workforce

12 BY adding: §§ 3-13-101 through 3-13-103 and the “Title 13. Video Lottery Facility Local

16 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
17 That §§ 3-13-101 through 3-13-103 and the title “Title 13. Workforce Management” of the  
18 Anne Arundel County Code (2005, as amended) is hereby renumbered to be §§ 3-14-101  
19 through 3-14-103 and the title “Title 14. Workforce Management”, respectively.

5                   **3-13-101. Established.**

6  
7                   THERE IS A VIDEO LOTTERY FACILITY LOCAL DEVELOPMENT COUNCIL FOR ANNE  
8 ARUNDEL COUNTY ESTABLISHED PURSUANT TO THE STATE GOVERNMENT ARTICLE, § 9-1A-  
9 31, OF THE STATE CODE.

11                  **3-13-102. Appointment.**

12  
13                  (A) **Composition.** THE MEMBERS OF THE COUNCIL SHALL BE APPOINTED IN  
14 ACCORDANCE WITH THE STATE GOVERNMENT ARTICLE, § 9-1A-31, OF THE STATE CODE,  
15 EXCEPT THAT THE SEVEN RESIDENTS OF COMMUNITIES IN IMMEDIATE PROXIMITY TO THE  
16 FACILITY AND THE FOUR REPRESENTATIVES OF BUSINESSES OR INSTITUTIONS LOCATED IN  
17 IMMEDIATE PROXIMITY TO THE FACILITY SHALL BE CHOSEN FROM A LIST OF SUCH  
18 RESIDENTS PRESENTED TO THE COUNTY EXECUTIVE BY THE COUNTY COUNCILMEMBER  
19 REPRESENTING THE DISTRICT IN WHICH THE VIDEO LOTTERY FACILITY IS LOCATED.

21                  (B) **Time of appointment.** THE MEMBERS OF THE VIDEO LOTTERY FACILITY LOCAL  
22 DEVELOPMENT COUNCIL FOR ANNE ARUNDEL COUNTY SHALL BE APPOINTED WITHIN 30  
23 DAYS AFTER ISSUANCE OF A VIDEO LOTTERY FACILITY LICENSE IN ANNE ARUNDEL COUNTY  
24 BY THE VIDEO LOTTERY FACILITY LOCATION COMMISSION.

26                  **3-13-103. Powers and duties.**

27  
28                  A COUNCIL SHALL HAVE THE POWERS AND DUTIES SET FORTH IN THE STATE  
29 GOVERNMENT ARTICLE, § 9-1A-31, OF THE STATE CODE.

31                  SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days  
32 from the date it becomes law.
