A BILL ENTITLED

1 AN EMERGENCY ORDINANCE concerning: Capital Budget and Program –  
2 Elizabeth’s Landing SECD – Additional Appropriation

3  
4 FOR the purpose of amending the Capital Budget by making an additional appropriation  
5 of funds to the Elizabeth’s Landing SECD capital project; amending the Capital  
6 Program and Capital Projects Bond Ordinance; and making this Ordinance an  
7 emergency measure.

9 BY amending: Capital Budget  
10 Capital Program  
11 Capital Projects Bond Ordinance

13 WHEREAS, the capital project, Elizabeth’s Landing SECD, Project No.  
14 Q541000, has an existing appropriation, and additional funding of \$23,262 in loan  
15 funds and technical and administrative services has become available from the  
16 Maryland Department of Natural Resources, which was not anticipated in budget  
17 estimates for fiscal year 2010; and

18  
19 WHEREAS, Sections 712 and 716 of the Charter authorize the County Council,  
20 upon request of the County Executive and by affirmative vote of five members of  
21 the County Council, to amend the capital budget to increase the total amount of  
22 appropriations to the capital budgets from revenues from sources anticipated in  
23 the budget but in excess of budget estimates for the current fiscal year; and

24  
25 WHEREAS, the County Executive is requesting that \$23,262 in loan funds and  
26 technical and administrative services from the Maryland Department of Natural

1 Resources be appropriated to the capital project, Elizabeth's Landing SECD,  
2 Project No. Q541000; and

4 WHEREAS, in accordance with Section 716 of the Charter, the County Executive  
5 and the Planning Advisory Board have recommended amendments to the Capital  
6 Budget; and

8 WHEREAS, the Controller has certified in writing that such funds are available  
9 for appropriation; now, therefore,

10

11 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*  
12 *Maryland,* that the Capital Budget for the fiscal year ending June 30, 2010, is hereby  
13 amended by making an additional appropriation in the amount of \$23,262 from the  
14 Maryland Department of Natural Resources, which was not anticipated in the budget  
15 estimates for fiscal year 2010, to the Elizabeth's Landing SECD, Project No. Q541000.

17 SECTION 2. *And be it further enacted,* That the Capital Program and Capital Projects  
18 Bond Ordinance for the fiscal year ending June 30, 2010, are hereby amended in  
19 accordance with the provisions of this Ordinance.

21 SECTION 3. *And be it further enacted,* That this Ordinance is hereby declared to be  
22 an emergency ordinance and necessary for the immediate preservation of the public  
23 peace, health, safety, welfare, and property, and being passed by the affirmative vote of  
24 five members of the County Council, the same shall take effect from the date it becomes  
25 law.
