1 AN ORDINANCE concerning: Video Lottery Facility Local Development Council

3 FOR the purpose of establishing a Video Lottery Facility Local Development Council;  
4 providing for the composition, time of appointment, and powers and duties of the  
5 Council; and generally relating to a Video Lottery Facility Local Development  
6 Council.

18 *Maryland,* That §§ 3-13-101 through 3-13-103 and the title "Title 13. Workforce  
19 Development" of the Arundel County Code (2005, as amended) are hereby renumbered  
20 to be §§ 3-14-101 through 3-14-103 and the title "Title 14. Workforce Development",  
21 respectively.

3                   **TITLE 13. VIDEO LOTTERY FACILITY LOCAL DEVELOPMENT COUNCIL**

5                   **3-13-101. Established.**

6  
7                   THERE IS A VIDEO LOTTERY FACILITY LOCAL DEVELOPMENT COUNCIL FOR ANNE  
8 ARUNDEL COUNTY ESTABLISHED PURSUANT TO THE STATE GOVERNMENT ARTICLE, § 9-  
9 1A-31, OF THE STATE CODE.

11                   **3-13-102. Appointment.**

12  
13                   (A) **Composition.** THE MEMBERS OF THE COUNCIL SHALL BE APPOINTED IN  
14 ACCORDANCE WITH THE STATE GOVERNMENT ARTICLE, § 9-1A-31, OF THE STATE CODE,  
15 EXCEPT THAT THE SEVEN RESIDENTS OF COMMUNITIES IN IMMEDIATE PROXIMITY TO  
16 THE FACILITY AND THE FOUR REPRESENTATIVES OF BUSINESSES OR INSTITUTIONS  
17 LOCATED IN IMMEDIATE PROXIMITY TO THE FACILITY SHALL BE CHOSEN FROM A LIST  
18 OF SUCH RESIDENTS PRESENTED TO THE COUNTY EXECUTIVE BY THE COUNTY COUNCIL.

20                   (B) **Time of appointment.** THE MEMBERS OF THE VIDEO LOTTERY FACILITY LOCAL  
21 DEVELOPMENT COUNCIL FOR ANNE ARUNDEL COUNTY SHALL BE APPOINTED WITHIN 30  
22 DAYS AFTER ISSUANCE OF A VIDEO LOTTERY FACILITY LICENSE IN ANNE ARUNDEL  
23 COUNTY BY THE VIDEO LOTTERY FACILITY LOCATION COMMISSION.

25                   **3-13-103. Powers and duties.**

26  
27                   THE COUNCIL SHALL HAVE THE POWERS AND DUTIES SET FORTH IN THE STATE  
28 GOVERNMENT ARTICLE, § 9-1A-31, OF THE STATE CODE.

30                   SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days  
31 from the date it becomes law.
