1 RESOLUTION reappointing certain members to the Anne Arundel County Adult Public
2 Guardianship Review Board

3
4 WHEREAS, the Family Law Article, § 14-402, of the Annotated Code of Maryland
5 requires that the county executive of a county, with the advice and consent of the
6 county council, appoint the members of an Adult Public Guardianship Review
7 Board; and

8
9 WHEREAS, the Family Law Article, § 14-402(a)(2), of the Annotated Code of
10 Maryland requires that one member shall be a professional representative of a local
11 department; two members shall be physicians, including one psychiatrist from a local
12 health department that employs psychiatrists; one member shall be a representative
13 of a local commission on aging; one member shall be a professional representative of
14 a local nonprofit social service organization; one member shall be a lawyer; two
15 members shall be lay individuals; one member shall be a public health nurse; one
16 member shall be a professional in the field of disabilities; and one member shall be a
17 person with a physical disability; and

19 WHEREAS, § 14-402(b)(1) provides that the term of a member is three years; and

21 WHEREAS, the terms of certain members of the Anne Arundel County Adult Public
22 Guardianship Review Board expired on or before August 31, 2009; and

24 WHEREAS, the County Executive, subject to the advice and consent of the County
25 Council, has reappointed Randall M. McLaughlin, M.D. (a physician), Mary C.
26 Brown (a lay individual), and Brenda C. Howard, LSWA (a professional
27 representative of a local nonprofit service organization), for three year terms that
28 expire on August 31, 2012; and

30 WHEREAS, the County Executive, subject to the advice and consent of the County
31 Council, has appointed Elizabeth P. Arnold, LCSW-C, to fill the position of the
32 representative of a local commission on aging for a three year term that expires on
33 August 31, 2012; and

34 WHEREAS, the County Council, after public hearing, finds that Randall M.

1 McLaughlin, M.D., Mary C. Brown, Brenda C. Howard, LSWA, and Elizabeth P.
2 Arnold, LCSW-C meet the eligibility requirements under the Family Law Article, §
3 14-402, of the Annotated Code of Maryland to serve on the Anne Arundel County
4 Adult Public Guardianship Review Board; now, therefore, be it

6 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby
7 approves the reappointments of Randall M. McLaughlin, M.D. (a physician), Mary C.
8 Brown (a lay individual), and Brenda C. Howard, LSWA (a professional representative of a
9 local nonprofit social service organization), and the appointment of Elizabeth P. Arnold,
10 LCSW-C (a representative of a local commission on aging), to serve as members of the Anne
11 Arundel County Adult Public Guardianship Review Board for three year terms that expire on
12 August 31, 2012; and be it further
