A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – NPDES Permit Program –
2 Additional Appropriation

3
4 FOR the purpose of amending the Capital Budget by making an additional appropriation
5 to the NPDES Permit Program capital project; and amending the Capital Program and
6 Capital Projects Bond Ordinance.

8 BY amending: Capital Budget
9 Capital Program
10 Capital Projects Bond Ordinance

12 WHEREAS, the capital project, NPDES Permit Program, Project No. D406900,
13 has an existing appropriation, and additional funding of \$50,000 has become
14 available from a grant from the Campbell Foundation, which was not anticipated
15 in budget estimates for fiscal year 2010; and

16
17 WHEREAS, Sections 712 and 716 of the Charter authorize the County Council,
18 upon request of the County Executive and by affirmative vote of five members of
19 the County Council, to amend the capital budget and to increase the total amount
20 of appropriations to the capital budget from revenues received from sources not
21 anticipated in the budget for the current fiscal year; and

23 WHEREAS, the County Executive is requesting that \$50,000 from a grant from
24 the Campbell Foundation be appropriated to the capital project, NPDES Permit
25 Program, Project No. D406900; and

1 WHEREAS, in accordance with Section 716 of the Charter, the County Executive
2 and the Planning Advisory Board have recommended amendments to the Capital
3 Budget; and

5 WHEREAS, the Controller has certified in writing that such funds are available
6 for appropriation; now therefore,

7

8 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
9 *Maryland,* That the Capital Budget for the fiscal year ending June 30, 2010, is hereby
10 amended by making an additional appropriation in the amount of \$50,000 from a grant
11 from the Campbell Foundation which was not anticipated in the budget estimates for the
12 fiscal year ending June 30, 2010, to the NPDES Permit Program capital project, Project
13 No. D406900.

15 SECTION 2. *And be it further enacted,* That the Capital Program and Capital Projects
16 Bond Ordinance for the fiscal year ending June 30, 2010, are hereby amended in
17 accordance with the provisions of this Ordinance.

18

19 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days
20 from the date it becomes law.
