A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – NPDES SD Retrofits –  
2 Additional Appropriation

3  
4 FOR the purpose of amending the Capital Budget by making an additional appropriation  
5 to the NPDES SD Retrofits capital project; and amending the Capital Program and  
6 Capital Projects Bond Ordinance.

8 BY amending: Capital Budget  
9 Capital Program  
10 Capital Projects Bond Ordinance

12 WHEREAS, the capital project, NPDES SD Retrofits, Project No. D499900, has  
13 an existing appropriation, and additional funding of \$360,000 has become  
14 available from the Chesapeake ~~Bay 2010 Trust Fund~~ via and Atlantic Coastal  
15 Bays 2010 Trust Fund Local Implementation Grant from the Maryland  
16 Department of Natural Resources, which was not anticipated in budget estimates  
17 for fiscal year 2010; and

18  
19 WHEREAS, Sections 712 and 716 of the Charter authorize the County Council,  
20 upon request of the County Executive and by affirmative vote of five members of  
21 the County Council, to amend the capital budget and to increase the total amount  
22 of appropriations to the capital budget from revenues received from sources not  
23 anticipated in the budget for the current fiscal year; and

1 WHEREAS, the County Executive is requesting that \$360,000 from a Chesapeake  
2 and Atlantic Coastal Bays 2010 Trust Fund Local Implementation Grant from the  
3 Maryland Department of Natural Resources be appropriated to the capital project,  
4 NPDES SD Retrofits, Project No. D499900; and

5  
6 WHEREAS, in accordance with Section 716 of the Charter, the County Executive  
7 and the Planning Advisory Board have recommended amendments to the Capital  
8 Budget; and

9  
10 WHEREAS, the Controller has certified in writing that such funds are available  
11 for appropriation; now therefore,

12  
13 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*  
14 *Maryland,* That the Capital Budget for the fiscal year ending June 30, 2010, is hereby  
15 amended by making an additional appropriation in the amount of \$360,000 from a  
16 Chesapeake and Atlantic Coastal Bays 2010 Trust Fund Local Implementation Grant  
17 from the Maryland Department of Natural Resources, which was not anticipated in the  
18 budget estimates for the fiscal year ending June 30, 2010, to the NPDES SD Retrofits  
19 capital project, Project No. D499900.

20  
21 SECTION 2. *And be it further enacted,* That the Capital Program and Capital Projects  
22 Bond Ordinance for the fiscal year ending June 30, 2010, are hereby amended in  
23 accordance with the provisions of this Ordinance.

24  
25 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days  
26 from the date it becomes law.
