20 (i) **Project labor agreements – prohibition.** NO PROCUREMENT CONTRACT MAY  
21 INCLUDE A CLAUSE THAT REQUIRES A PARTY TO PARTICIPATE IN, OR OFFERS A BONUS  
22 OR PREFERENTIAL TREATMENT TO A PARTY WHO PARTICIPATES IN, A PROJECT LABOR  
23 AGREEMENT IN WHICH A PARTY MUST ADHERE TO OBLIGATIONS CONCERNING UNION  
24 REFERRAL, UNION SECURITY, OR COLLECTIVELY BARGAINED COMPENSATION OR  
25 BENEFITS.



SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days from the date it becomes law.






