1 RESOLUTION concerning a petition to the Maryland Higher Education Commission
2 for Anne Arundel Community College funding of the design of the Ludlum Hall
3 Administration Building Renovation

5 WHEREAS, the Maryland General Assembly has enacted various community
6 college loan acts that provide funds to assist the counties in the financing of the
7 cost of the acquisition of land and in the construction of public junior,
8 community, or regional community college buildings and facilities, the cost of
9 which was incurred after the effective dates of the acts; and

11 WHEREAS, § 11-105(j)(3)(i) of the Education Article of the Annotated Code of
12 Maryland requires that a county desiring to participate in the financial assistance
13 provided in the acts must file a petition with the Maryland Higher Education
14 Commission, together with a complete proposal for each project for which
15 financial assistance is desired; and

17 WHEREAS, the Board of Trustees of Anne Arundel Community College
18 proposes to procure the design of the Ludlum Hall Administration Building
19 Renovation for the public community college at Arnold, Maryland; and

21 WHEREAS, upon resolution duly adopted by it, a copy of which is appended
22 hereto, the Board of Trustees has requested Anne Arundel County to petition the
23 Maryland Higher Education Commission for the sum of ~~\$237,312~~ \$226,000
24 needed for the purpose of assisting the financing of the public community college
25 project, which is described in the application for financial assistance; and

27 WHEREAS, by this Resolution, the County Executive expresses his approval of
28 this project and requests that the County Council petition the Maryland Higher
29 Education Commission for the funding; now, therefore, be it

31 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
32 *petitions the Maryland Higher Education Commission for a grant of ~~\$237,312~~ \$226,000*
33 *from the available funds of the various community college loan acts in order to*
34 *participate in said financial assistance; and be it further*

1 *Resolved*, That, subject to appropriation and availability of funds, the Anne Arundel
2 County Council shall provide all of the remaining funds necessary to complete the
3 described project even if the Maryland Board of Public Works approves a grant which is
4 less than the amount requested by this petition; and be it further

6 *Resolved*, That a copy of this Resolution be sent to County Executive John R.
7 Leopold and to the Secretary of the Board of Trustees of Anne Arundel Community
8 College.
