A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Security Related Upgrades –  
2 Additional Appropriation

3  
4 FOR the purpose of amending the Capital Budget by making an additional appropriation to  
5 the Security Related Upgrades capital project from the Local Education fund balance;  
6 and amending the Capital Program and Capital Projects Bond Ordinance.

8 BY amending: Capital Budget  
9 Capital Program  
10 Capital Projects Bond Ordinance

12 WHEREAS, Section 716 of the Charter authorizes the County Council, upon request  
13 of the County Executive and by the affirmative vote of five members of the County  
14 Council, to amend the capital budget and to increase the total amount of  
15 appropriations to the capital budget from revenues received from anticipated sources  
16 but in excess of estimates in the budget for the current fiscal year; and

17  
18 WHEREAS, § 5-107(b)(1) of the Education Article of the Annotated Code of  
19 Maryland requires that expenditures for school building construction be made in  
20 accordance with the cost approved by the County Council for each project; and

21  
22 WHEREAS, the Security Related Upgrades capital project, Project No. E538100, has  
23 an existing appropriation in the Capital Budget for the Fiscal Year ending June 30,  
24 2007; and

1 WHEREAS, the Local Education Fund has a fund balance in an amount not less than  
2 \$631,700; and

4 WHEREAS, the County Executive is requesting that funds be appropriated from the  
5 Local Education Fund fund balance to the Security Related Upgrades capital project  
6 in the amount of \$631,700; and

8 WHEREAS, the Board of Education has requested the additional appropriation; and

10 WHEREAS, in accordance with Section 716 of the Charter, the County Executive  
11 and the Planning Advisory Board have recommended amendments to the Capital  
12 Budget; and

14 WHEREAS, the Controller has certified in writing that the funds are available for  
15 appropriation; now, therefore,

16

17 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
18 That the Capital Budget for the fiscal year ending June 30, 2007, is hereby amended by  
19 making an additional appropriation from anticipated sources but in excess of estimates in the  
20 budget for the current fiscal year in the amount of \$631,700 (Board of Education PayGo) to  
21 the Security Related Upgrades capital project, Project No. E538100.

23 SECTION 2. *And be it further enacted,* That the Capital Program and Capital Projects  
24 Bond Ordinance are hereby amended in accordance with the provisions of this Ordinance.

26 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days  
27 from the date it becomes law.
