A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Careers Building  
2 Renovation – Additional Appropriation

3  
4 FOR the purpose of amending the Capital Budget by making an additional appropriation  
5 of funds to the Careers Building Renovation Capital Project; and amending the  
6 Capital Program and Capital Projects Bond Ordinance.

8 BY amending: Capital Budget  
9 Capital Program  
10 Capital Projects Bond Ordinance

12 WHEREAS, the capital project, Careers Building Renovation, Project No.  
13 J430500, has an existing appropriation; and

14  
15 WHEREAS, Sections 712 and 716 of the Charter authorize the County Council,  
16 upon request of the County Executive and by the affirmative vote of five  
17 members of the County Council, to amend the capital budget and to increase the  
18 total amount of appropriations to the capital budget from revenues received but  
19 not anticipated in the budget for the current fiscal year; and

21 WHEREAS, the County Executive is requesting that \$1,008,400 from the Anne  
22 Arundel Community College net assets be appropriated to the capital project,  
23 Careers Building Renovation, Project No. J430500; and

25 WHEREAS, in accordance with Section 716 of the Charter, the Planning  
26 Advisory Board has recommended this amendment to the Capital Budget; and

1       WHEREAS, the Controller has certified in writing that such funds are available  
2       for appropriation; now, therefore,

4       SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*  
5 *Maryland,* That the Capital Budget for the fiscal year ending June 30, 2008, is hereby  
6 amended by making an additional appropriation in the amount of \$1,008,400 from Anne  
7 Arundel Community College net assets, which was not anticipated in the budget  
8 estimates for the fiscal year ending June 30, 2008, to the Careers Building Renovation  
9 capital project, Project No. J430500.

11       SECTION 2. *And be it further enacted,* That the Capital Program and the Capital  
12 Projects Bond Ordinance for the fiscal year ending June 30, 2008 are hereby amended in  
13 accordance with the provisions of this Ordinance.
