A BILL ENTITLED

1 AN ORDINANCE concerning: Capital Budget and Program – Library Renovation –
2 Additional Appropriation

3
4 FOR the purpose of amending the Capital Budget by making an additional appropriation
5 of funds to the Library Renovation Capital Project; and amending the Capital
6 Program and Capital Projects Bond Ordinance.

8 BY amending: Capital Budget
9 Capital Program
10 Capital Projects Bond Ordinance

12 WHEREAS, the capital project, Library Renovation, Project No. L479600, has an
13 existing appropriation, and additional funding of \$92,000 has become available
14 from the Maryland County Library Capital Grants Program of the Division of
15 Library Development Services, which was not anticipated in budget estimates for
16 fiscal year 2008; and

18 WHEREAS, Sections 712 and 716 of the Charter authorize the County Council,
19 upon request of the County Executive and by affirmative vote of five members of
20 the County Council, to amend the capital budget and to increase the total amount
21 of appropriations to the capital budget from revenues received from sources not
22 anticipated in the budget for the current fiscal year; and

24 WHEREAS, the County Executive is requesting that \$92,000 from the Maryland
25 County Library Capital Grants Program of the Division of Library Development

1 Services be appropriated to the capital project, Library Renovation, Project No.
2 L479600; and

4 WHEREAS, in accordance with Section 716 of the Charter, the Planning
5 Advisory Board have recommended this amendment to the Capital Budget; and

7 WHEREAS, the Controller has certified in writing that such funds are available
8 for appropriation; now therefore,

9

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
11 *Maryland* that the Capital Budget for the fiscal year ending June 30, 2008, is hereby
12 amended by making an additional appropriation in the amount of \$92,000 from the
13 Maryland County Library Capital Grants Program of the Division of Library
14 Development Services, which was not anticipated in the budget estimates for the fiscal
15 year ending June 30, 2008, to the Library Renovation capital project, Project No.
16 L479600.

18 SECTION 2. *And be it further enacted,* That the Capital Program and Capital
19 Projects Bond Ordinance for the fiscal year ending June 30, 2008, are hereby amended in
20 accordance with the provisions of this Ordinance.

22 SECTION 3. *And be it further enacted,* That this Ordinance shall take effect 45 days
23 from the date it becomes law.
