DEPARTMENT OF INSPECTIONS AND PERMITS

As per the requirements of the Anne Arundel County Grading Ordinance, Article 21, Title 2, Section 2-211(B) which reads:

(B) ON SITES WHERE MORE THAN TWO ACRES OF LAND WILL BE DISTURBED, BEFORE COMMENCEMENT OF CLEARING OR GRADING UNDER A GRADING PERMIT, A PERMITTEE SHALL PROVIDE TO THE DEPARTMENT A LISTING OF ALL GRADING OR SITE IMPROVEMENT CONTRACTORS AND SUBCONTRACTORS THAT WILL BE PERFORMING WORK ON THE SITE. THE LISTING SHALL INCLUDE THE LEGAL NAME, ADDRESS, AND TELEPHONE NUMBER OF EACH CONTRACTOR AND SUBCONTRACTOR AND THE NAME OF A RESPONSIBLE INDIVIDUAL SUPERVISING THE WORK PERFORMED BY THE CONTRACTOR OR SUBCONTRACTOR. EACH PERMITTEE SHALL CERTIFY THAT THE PERMITTEE HAS REVIEWED THE APPROVED PLAN AND ALL REQUIREMENTS WITH EACH CONTRACTOR AND SUBCONTRACTOR WHO IS INVOLVED IN GRADING OR SITE IMPROVEMENTS AND ADVISED THOSE CONTRACTORS AND SUBCONTRACTORS TO PERFORM ALL WORK IN ACCORDANCE WITH THE GRADING PERMIT, APPROVED PLAN, AND THIS TITLE.
