Count 1: Violation of the Rules and Regulations of the Board of License Commissioners for Anne Arundel County, Chapter 3, Section 3.01 (c) "Ownership and Operation"; RE: Violation notice #0827 by Chief Inspector Van Lee, dated July 7, 2009.

Count 2: Violation of the Rules and Regulations of the Board of License Commissioners for Anne Arundel County, Chapter 3, Section 3.02 (a) & (b) "Cooperation"; RE: Violation notice #0827 by Chief Inspector Van Lee, dated July 7, 2009.

In light of admission and testimony presented, the Board makes the following findings.
