Drug Offenses

Linthicum

On April 16, 2008 at approximately 2200 hours, members of the Anne Arundel County Police Special Enforcement Section, members of the Western District Tactical Narcotics Team and members of the Drug Enforcement Administration conducted a search and seizure warrant at 337 Silky Oak Court, Linthicum Heights, MD, 21090. The search warrant was the culmination of a six-month investigation of the resident of the home of, Larry Shields, who was suspected of distributing large amounts of cocaine within Anne Arundel County.

A search of the residence and suspect's vehicle resulted in the recovery of approximately 571 grams of suspected cocaine hydrochloride (powder) and the recovery of approximately 150 grams of suspected "crack" cocaine.

On April 21, 2008 a second search and seizure warrant was conducted at the residence, which resulted in the additional seizure of approximately 88 grams of suspected "crack" cocaine. The seized cocaine has a combined street value in excess of \$80K.

The investigation resulted in the arrest of five suspects. Three suspects will be charged in State Court with drug offenses. Two suspects will be charged with Federal drug trafficking charges in the US District Court. The following is a list of suspects and their charges:
