WESTERN DISTRICT

Burglary

On 4/21/09, officers from the Western District PACT Unit responded to the 8200 block of Severn Orchard Circle, Severn, for a report of a burglary. Officers determined that the suspect's access to the residence had been gained through the attic. Officers located an identification card that had apparently been dropped by the suspect during the burglary. Further investigation revealed that the suspect had also made access into an adjoining townhome in the same block by accessing the attic hatch as well.

On 4/29/09, at 8:30 a.m. detectives from the Western District Detective Unit executed a search and seizure warrant at 8211 Severn Orchard Circle, Severn. Inside the residence, detectives located the suspect. Also inside, detectives were able to determine the suspect had cut out the drywall in the attics to access the surrounding residences. The suspect was arrested and charged with 2 counts of first degree burglary.

Strong Arm Robbery

On 4-30-09 at 2:35 p.m. officers from Western District responded to the area of Hammonds Lane and Higgins Drive in Odenton, in reference to a call for a strong arm robbery and assault. Investigation revealed that two juveniles were assaulted and robbed by four subjects. One juvenile victim was transported to a hospital for minor injuries and was later released. The subjects were described as two black males, one Asian male, and a black female.

While units saturated the area, three of the subjects were seen crossing Annapolis Road toward the Shelter Cove Apartments. The subjects fled into the woods, but were located and detained. All three subjects were identified by the victims and witnesses as having committed the robbery. Electronic devices stolen from the victims were not recovered. The search was conducted by officers assigned to Patrol, District Detectives, PACT, K-9, and School Resource

Units, as well as the Howard County Air Unit. Investigation is ongoing to identify the remaining male subject. The below listed suspects were charged with Robbery, Assault, and Theft.
