Dear Motorists,

As a result of your crash, you have the right to request the police officer to conduct a formal crash investigation.

However, increasingly heavy traffic and the accompanying larger number of traffic crashes have made it necessary to discontinue the investigation of certain property damage crashes. This policy will permit the Anne Arundel County Police Department to respond more promptly to crashes involving serious personal injury and other emergency call requiring immediate police attention.

The policy of the Anne Arundel County Police Department is to investigate traffic crashes involving death, personal injury, and hit and run crashes within an eight-hour time frame or with extenuating circumstances. In addition, officers will investigate property damage crashes occurring on a roadway when the vehicle or vehicles cannot be safely driven from the scene or require a tow truck. You may also specifically request an investigation be conducted if you are a party to the crash (owner, drivers, passenger).

For your convenience, the reverse side of this form will assist in providing you the necessary information required by your insurance company.
