**Permit Holder Agreement**

- This permit is only valid for persons participating in car-top watercraft sports, such as kayaking, canoeing, kite boarding, small craft sailing, and windsurfing. **No motorized watercraft may launch, land or park on the beach.**
- If main gate is closed upon arrival return to closed immediately after entering or leaving the park
- Close chain and lock immediately after entering or leaving the windsurfing permit area. The locked windsurfing area is for *permit holder use only*. One car per permit allowed. Guests not included.
- The lock combination is for permit holder only. (Sharing of the combination may result in loss of permit with no refund.)
- Only use the designated windsurfing parking area and rest rooms. Vehicles are not allowed to drive on the beach
- No Pets allowed, unless service animal as designated by the ADA.
- Take all trash with you when leaving. Help keep our park and bay clean.
- No camping or open fires.
- Obey regulation signs as posted.
- Mayo Beach Park is open 7 days a week from dawn to dusk with a valid permit.

**WAVIER**

The applicant for himself/herself, all family members and guest, hereby agree to hold harmless ANNE ARUNDEL COUNTY MARYLAND from any and all bodily injuries (including death) arising out of or connected with the lawful use of MAYO BEACH PARK facilities. The applicant further agrees to personally indemnify ANNE ARUNDEL COUNTY MARYLAND or IT'S EMPLOYEES AS A RESULT OF BODILY INJURY (including death) sustained by any members of his or her guest while using the MAYO BEACH PARK facility. The permit holder understands that open water activities present certain inherent dangers, the risk of which must be assumed by those participating in windsurfing, small craft sailing, canoeing, kiteboarding, kayaking, etc. Participants are urged to use the BUDDY system and follow all safety guidelines for the craft they are navigating.
