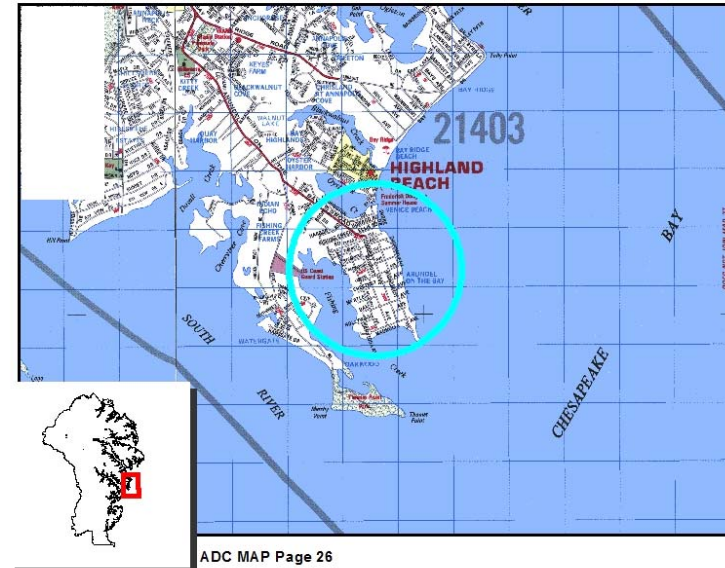
FY2018 County Executive Request
