Visitor Information

WELCOME

All visitors will be required to pass through a metal detector upon entry. Before doing so....

- Persons visiting inmates and Pretrial Supervised Release clients must secure personal items in lobby lockers, to include purses, coats, cell phones, etc.
- Professional visitors may secure belongings in lockers, or may retain them for visual inspection of their contents by an Officer. Following passage through the metal detector, they will be returned.
- Law Enforcement Officers must secure all firearms and weapons in gun boxes located in the Staff vestibule. Access to the vestibule will be granted by the Receptionist or JRDC Officer.
- Visitors and volunteers authorized to enter the secure facility must secure personal items not relevant to the purpose of their visit in lockers. All other items will be searched.

Cameras, tape recorders, and other such items are prohibited unless authorized by the Assistant Facility Administrator, Facility Administrator, or Superintendent.

Persons with disabilities are invited to request special accommodations.

JENNIFER ROAD DETENTION CENTER INMATE VISITOR INFORMATION

- Inmates are permitted to have 2 visits per week with family members or personal friends.
- Visitors are required to produce photo identification. If the visitor does not have photo ID he or she will be permitted to present two forms of identification bearing exact names; for example, credit cards, social security card, etc. Visitors under the age of 18 are not required to present identification provided a parent or legal guardian accompanies them. Legal guardians may be requested to produce guardianship documents. If acceptable identification is not presented, the visit will be denied.
- There is no limitation on the age of visitors. Unless married to the inmate, persons under the age of 18 must be accompanied by their parent or legal guardian. Being accompanied by an adult who is not the parent or guardian of the visitor is not an acceptable substitute. Any visitor under 18 who claims to be married to an inmate must present a marriage certificate in addition to a photo I.D.
- Visitors are required wear shoes and dress in a fashion that is not revealing or provocative. Revealing and provocative clothing includes but is not limited to see-through apparel, tops and blouses with plunging necklines, and apparel with high-cut slits.
- Visits are one hour in duration unless visitation activity is heavy and termination after 30 minutes is necessitated. Up to two visitors may visit an inmate at a time.
- Visitors who become disruptive or create a disturbance will be warned to cease the behavior or the visit will be terminated. Visitors who refuse to comply with the direction of JRDC staff risk suspension or termination of visiting privileges.
- Children must be supervised by the accompanying adult at all times in the lobby and visiting area. Failure to do so will result in termination of the visit.
- The visiting area is monitored. While in the visiting area, visitors are expected to maintain a normal voice level and conduct themselves in an appropriate manner.
- Chewing gum, food and beverages are prohibited.
- Disrespect to staff and disregard of these rules is considered a serious matter and may result in termination of the visit.
- Visitors must leave the visiting booth in the same condition in which found. Evidence of tampering or vandalism will result in permanent suspension of visiting privileges and criminal prosecution.
- The introduction of contraband into a correctional facility is a criminal offense. Contraband includes but is not limited to tobacco products and lighting products, illegal substances, alcohol, and weapons of any kind. Any attempt to introduce contraband will result in permanent suspension of visiting privileges and criminal prosecution.

JENNIFER ROAD DETENTION CENTER PROFESSIONAL VISITOR INFORMATION

- Attorneys, law enforcement officials, process servers, approved clergy, medical professionals, media representatives, bondsmen, and other persons wishing to visit an inmate in a professional capacity will be allowed to visit in a Professional interview room. Professional visitors must produce photo identification and identification which verifies profession; for example, media or agency identification, Certificate of Ordination, Certificate of Islamic Studies, badge, Bar Association card, etc. Paralegals must produce a letter on law firm letterhead which authorizes the visit on behalf of the attorney.
- Members of the clergy may register as Professional visitors by contacting the Chaplain at 410-222-4549. Upon the Chaplain's review and verification of credentials, clergy will be placed on a Pre-Approved Clergy list and will not be required to produce his/her credentials when visiting an inmate for professional purposes.
- Attorney visits shall be authorized on a 24-hour, 7 days per week basis. Other professional visits are allowed daily between 8:30 a.m. and 10:00 p.m. unless authorized in advance by the Captain, Assistant Facility Administrator, or Facility Administrator. Professional visits are not limited in duration.
- With the exception of attorneys, a person seeking a Professional visit who is a member of the inmate's family will be denied professional visiting privileges.
- Professional visits are considered private and confidential. Monitoring of the visit is limited to visual oversight as may be required to ensure the security of JRDC, the visitor and inmate.
- Professional interview rooms are equipped with secure portals for passing of documents. Professionals wishing to use the portals may do so by requesting the assistance of the Lobby Officer. Portals will be unsecured only while an Officer is present.
- Contact visits are not permitted.

JENNIFER ROAD DETENTION CENTER VISITING AREA RULES

The following rules have been established to ensure that visitors and inmates have successful visits. As a guest of this facility, your cooperation is expected and appreciated. Please note that this area is monitored and violation of these rules may result in suspension of your visit.

- No chewing gum, food or beverages are allowed.
- Visitors must supervise and maintain control of children in your company.
- Visitors are expected to maintain normal voice levels and conduct themselves in an appropriate manner.
- Visitors must be respectful of JRDC staff and other visitors.
- Any tampering with or vandalizing of the area will result in permanent suspension of visiting privileges and criminal prosecution.
- The introduction of contraband into a correctional facility is a criminal offense. Contraband includes but is not limited to tobacco products, lighting materials, illegal substances, and weapons of any kind. Visitors who attempt to introduce contraband will lose their visiting privileges and face criminal prosecution.

- Inmates are permitted to have 3 visits per week with family members or personal friends.
- Visitors are required to produce photo identification. If the visitor does not have photo ID he or she will be permitted to present two forms of identification bearing exact names; for example, credit cards, social security card, etc. Visitors under the age of 18 are not required to present identification provided an adult accompanies them. If acceptable identification is not presented, the visit will be denied.
- There is no limitation on the age of visitors. Unless married to the inmate, persons under the age of 18 must be accompanied by an adult. Any visitor under 18 who claims to be married to an inmate must present a marriage certificate in addition to a photo I.D.
- Visitors are required wear shoes and dress in a fashion that is not revealing or provocative. Revealing and provocative clothing includes but is not limited to see-through apparel, tops and blouses with plunging necklines, and apparel with high-cut slits.
- Visits are one half hour in duration. Up to 2 visits may be taken in one day. Up to two adult visitors may visit an inmate at a time.
- Visitors who become disruptive or create a disturbance will be warned to cease the behavior or the visit will be terminated. Visitors who refuse to comply with the direction of ORCC staff risk suspension or termination of visiting privileges.
- Children must be supervised by the accompanying adult at all times in the lobby and visiting area. Failure to do so will result in termination of the visit.
- The visiting area is monitored. While in the visiting area, visitors are expected to maintain a normal voice level and conduct themselves in an appropriate manner.
- Chewing gum, food and beverages are prohibited.

- Cell phones, cameras or recording devices are not permitted unless authorized by CFA, ACFA or Captain.
