#### Accomplishments

A. The primary accomplishment of the Commission during 2017 was the planning and execution of the Anne Arundel County VAC Expo on April 20, 2017 at Annapolis High School. The Expo was very well received with several hundred veterans in attendance.

Welcoming remarks were made by the County Executive and the keynote address was provided by the Maryland Secretary of Veterans Affairs, George W. Owings III. The Expo was a "tabletop" event with 40+ veteran service and commercial organizations that serve veterans, plus classroom sessions for presentations.

- B. During regularly scheduled quarterly meetings, the Commission's Agendas included presentations by a range of Federal, state and county organizations serving veterans, useful in educating the Commissioners who are involved with outreach to county veterans. As an example, Brooks Tucker, Assistant Secretary for Veteran's Affairs, highlighted the VA's priorities during the current administration: focusing on a clinical-driven process, establishing accountability (including benefits claims), utilizing technology, allocating patients to match current infrastructure, and coordinating community care.
- C. Attendance at various veteran-related County events.

#### Proposed Initiatives for 2018

Support state legislation regarding state income tax exemption for retired veterans,

Increase participation in appropriate veteran-oriented events,

Continue support of the newly established Anne Arundel County Veterans Court,

Finalize revised Commission By-Laws,

Develop a pamphlet of VSO information for veterans lacking internet access (include AAC/Fed/State descriptions and contact info),

Investigate the need for a communications plan for distributing monthly communiqués to county VSOs, (but not to duplicate Maryland Dept of Veterans Affairs Friday email blasts),

Perform annual website review and submit updates to IT Department,

Investigate/arrange quarterly, advertised, small-scale (i.e., not Expo-sized), topically-focused workshops at various locations around the county, and

Investigate Community Veterans Engagement Boards (examples: Montgomery and Frederick Counties) and "clearinghouse" database for "Serving Together" –type initiatives.
