Eight (8) Veterans Affairs Commission meetings were held on the following dates: February 21st, March 14th, April 4th, May 2nd, June 13th, September 5th, October 18th and December 12th.

- A. Attended/participated in various veteran-related state and county events, including: Homeless Outreach (JAN), Maryland Veterans Caucus' Advocacy Day (FEB), Hospice of the Chesapeake's Welcome Home Vietnam Veterans Day (MAR), American Legion Post 141's Veteran Health and Wellness Expo (JUN), Maryland Suicide Prevention Task Force for Service Members, Veterans and Families (AUG & SEP), AACC Mental Health Fair (SEP), "Dress for Success" event held for Veterans and Transitioning Service members (SEP), County Police/Fire Departments' Veteran Appreciation Day (OCT), AACC Veterans Day observance (NOV), and Veterans Benefits dinner at American Legion Post 141 (DEC).

- C. Planned and conducted (with American Legion Post 141) the Memorial Day Service at the Annapolis World War II Overlook (MAY.)
- D. Co-hosted (with MDVA) the first "Service Member, Veteran and Families Wellness Round Table" in support of the Maryland Suicide Prevention Task Force, supporting the Governor's Commission on Suicide Prevention.

Proposed Initiatives for 2019

- 1. Seek to establish a county "Veterans Service Officer/Veterans Services Manager" position.
- 2. Encourage County Veteran Service Organizations' (VSOs') participation in the County Veterans Court Mentorship Program.
- 3. Encourage County VSO's to "adopt and visit" veterans in County Assisted Living Facilities, nursing homes, and neighborhoods.
- 4. Support Hospice of the Chesapeake's Welcome Home Vietnam Veterans event (March 29th) via table presence, in conjunction with the county Department of Aging.
- 5. Plan and conduct the Anne Arundel County Veterans EXPO2019 at the Annapolis High School (tentative date: April 27th.)
- 6. Support Maryland legislative initiatives pertaining to veterans via for example the Maryland Veterans Caucus.

- 7. Revisit updating the Commission's Bylaws.
- 8. Re-establish a current Facebook presence.
- 9. Research the Serving Together Project, a program of EveryMind, affiliated with AmericaServes.
- 10. Plan and conduct the 2019 Memorial Day event (May 27th), in conjunction with VSO's.
- 11. Investigate holding a Welcome Home for Korean Veterans event on July 27th (Armistice Day), to include a county proclamation and ceremony.
