P.S. My daughter also commented on how good looking your firefighters were - my wife agreed!



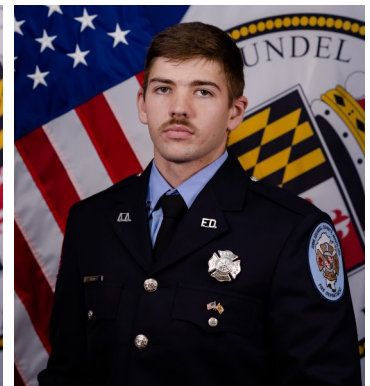
