Good Evening Lieutenant,

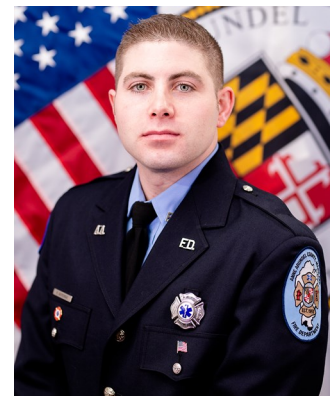

I wanted to pass along a "Thank you" and job well done for one of your Company's recent actions. On Friday, February 19<sup>th</sup>, 2021, one of our off-duty Firefighters (FF Martin Mahon, 32-B) suffered an injury while at his residence in Pasadena. With him being injured, he instructed his wife to call 911, and within minutes, Engine Company 10 and Medic 10 responded and arrived on-scene.

Even before identifying himself as an off-duty Prince George's County Firefighter, FF Mahon stated that the members from Company 10 performed excellent treatment on his injuries and made him feel as if they were treating "one of their own." While the medic crew meticulously tended to his injuries, the Engine crew helped calm his frantic wife and ensured her that he was in good hands. The medic crew carefully loaded FF Mahon into their unit, as to not cause further discomfort, administered pain medication consistent with their protocols and transported him to Baltimore Washington Medical Center (BWMC).

After transferring care to the staff of BWMC, the members from Medic 10 frequently checked in on Brother Mahon during subsequent transports throughout the remainder of their shift. I'm happy to report that FF Mahon underwent surgery later that afternoon and is now at home resting with a good prognosis.

On behalf of the members of the Prince George's County Fire Department, I wanted to pass along a sincere "Thank You" for taking care of our injured brother and his family during their time of need. I know I speak on behalf of Brother Mahon, as well as the dozens of Prince George's County Firefighters that call Anne Arundel County home, when I say that "the brotherhood is alive and well."

Please pass along our gratitude to the Commander's and members of Company 10.
