Dear Chief Wolford,


My name is Rob Reed, Sr. On Thursday May 18, 2022 in the early hours of that morning, I was adding DEF to my personal vehicle. The fill port is located in my engine compartment. I was using my cell phone as a flashlight. I unexpectedly knocked it over and it fell down an air vent. When I reached in to retrieve it, my hand became stuck. After about 30 minutes of me and my wife trying to free my hand with various things around the house, it became clear to both of us I needed help. My wife called 911 and a fire truck and paramedic unit from the Armiger Station arrived at my side. I found out later that Lieutenant Mike Mayo, FF Charles Keeney, and FF Josh Lyons were on the engine, and FF Casey Ross, and FF Sean Moore were on the Paramedic unit. All 5 displayed the utmost professional attitude. They all made a very embarrassing situation for me more comfortable. In a matter of minutes, they freed my hand and asked me if I needed medical attention. I declined.

I would like to ask you if you and your department would recognize these 5 individuals for exactly what they are..... TRUE PROFESSIONALS!! You should be very proud to have men and women that represent a Fire Department as respectable as the Anne Arundel County Fire Department. These 5 individuals represent the highest standards.

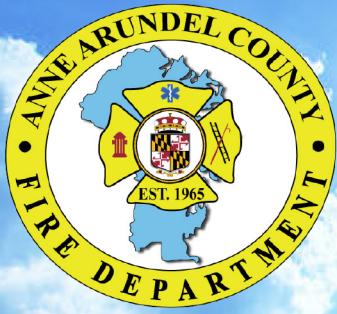

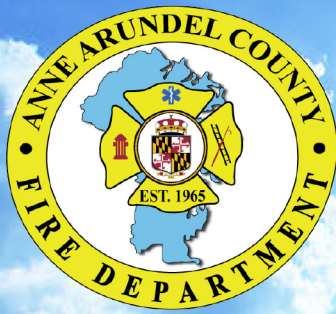

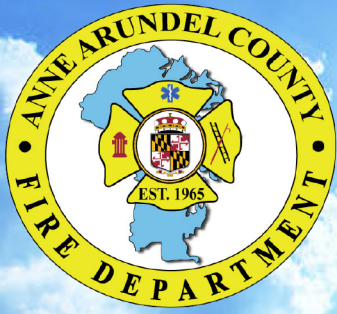
I want you to know how great both teams were in providing care to me. I had hoped to remember their names, but have been unable. I am sure you can determine who they are based on the time of dispatch.
