A public meeting has been scheduled for **Tuesday**, **November 29**, **2022** from **6:00-8:00pm** via the ZOOM.us platform by using the link or phone numbers above.

During the meeting, DPW will discuss plans to build the first phase of an environmental education and research Center at the Emory Water Nature Preserve of Jug Bay Wetlands Sanctuary, located at 6023 Pindell Road. This phase will include a parking lot, 8 cabins, 1 bathhouse, 1 outdoor pavilion, a picnic area, pathways, storm water facilities and landscaping. These structures and facilities will support short-and long-term research, education, stewardship, and public recreation goals. Design is expected to be completed in spring 2023. This meeting will be audio and video recorded.


