This virtual public meeting is started at approximately 5:57 p.m. on Tuesday, June 14, 2022.

Bruce Bruchey of Anne Arundel County began by introducing himself and the project team and stating the purpose of the meeting. The Project Team includes Bruce Bruchey, DRP Capital Projects Manager; Melissa Harlinski, Department of Public Works (DPW) Project Manager; Randy Hughes, Whitney, Bailey, Cox & Magnani, LLC. (WBCM) Project Manager. Bruce gave an overview of the general meeting agenda and procedure for asking questions both during and after the meeting. Bruce then turned it over to WBCM to present the 30% Schematic Design for Deale Community Park.

Randy Hughes of WBCM gave a brief overview of the project timeline including the master plan process and prior stakeholder meetings that we used in the master plan development. A general overview of the project was then given that included project location, key project information including environmental features and potential required modifications. This was followed by a schematic design presentation that included project overview of the park program and design elements, parking and site circulation, road frontage improvements, environmental features, and stormwater management. This was followed by a general outline of the next steps and the anticipated project schedule. Randy then turned the meeting back over to Bruce Bruchey to facilitate the questions and answers period of the meeting.

46 questions were asked during the meeting and comments were received during the public comment period. Please see the attached summary of questions posed and synopses of the answers that address the overarching themes of questions posed before, during, and after the meeting.

Statement 1 (Jonathan Guy): I will write my questions concerns here under a reservation of rights that this process is neither fair nor appropriate for impacted residents.

Response 1: Noted

Question 1 (Jonathan Guy): First, I speak on behalf of Mr. and Mrs. Flores, Mr. and Mrs. Turner, each of whom live on Deale Churchton Road near the proposed community park. I also speak on behalf of Sacred. First point is that the Master Plan (MP) is not in accordance with the SAP from 2001 despite asserting just that on pg 4 of the MP. The SAP on page 100 expressly provides for a community center to be built to "form a unified community complex with the existing library and new park facility." The SAP was approved by the AA Council and the community. The MP ignores the SAP's requirement for a community center. Please explain. Second the MP has three concepts, A B and C. Each includes the same elements just in different locations. DPW choose concept B. That has pickleball courts located near homes and a church. The other concepts did not. Pickleball is great idea but not to violate local noise ordinances. Across the country residents are concerned about the noise, which is a pop 25 decibels higher than tennis. The pickle ball courts could easily be located elsewhere where everyone can enjoy and no one's peace is disturbed. Third point is that our understanding is that this will now go to permitting but before any public meeting where everyone, not just impacted residents, can raise questions. That general public meeting should happen before permitting, including to allow residents to raise concerns about lack of community center required by the 2001 SAP. Fourth point is that Sacred long ago asked DPW about lack of community center on 4/21. No response was given. Sacred next submitted a MD FOIA request in October 2021. They are still waiting to receive those emails and other correspondence that would, presumably, share

some light on why DPW refuses to follow the clear strictures of the SAP with regard to a community center.

Question 1 (Erica Jackson, Vincent Moulden): This question was answered in parts. The process is that the County reached out to some of the neighbors in the Deale area. We met with them several times over a period of time to discuss what the elements of a park looks like. It is my understanding that the small area plan; it said that "the Deale Village area is in great need of some park land area to give balance to the commercial high density and residential areas the athletic fields behind the Deale Elementary School are at capacity" and then it continues to go on "The SAP recommended that the County purchase a 19.94 acre parcel from the Deale Elks for use as a park." So then the idea of the park north of the library is presented as an example not a recommendation or guidance from the SAP. So the County did not purchase this specific property that was listed in the SAP. The SAP lists ideas for what the County and the citizens would like to see in the community, it sort of serves as a guideline and then it presents suggestions on how we get there. The focus of this project is on the park development because we have 12 acres, which is not the same as the 19 that was requested and we are able to give the community something at this point. Vincent Moulden speaks on the community center and where it is headed. The Deale Library is a potential future site for a community center, when asked about the possibility of adding a community space to the library on the park side, the library said they were okay with the idea. They also shared that they hope to build a more extensive South County library and may potentially leave the current facility which could give us the option to use the building as a community center. The County Executive is open to exploring both those options. Answering part 2: To clarify that question we did a master plan and we established a list of elements that the committee all agreed on. The master plan was an effort to try to show different variations of what could be fixed on the site. We can make note on the comment about the pickle ball and reevaluate that with the design team. Answering part 3: This is that general public meeting where the community is allowed to raise all the questions and concerns that they have about the process. Because we are only that the 30% design phase, that gives us a little flexibility to make some changes but the idea of the community center is probably not going to move forward at this location. Response to 4th point: It's my understanding that the FOIA request is in process and there has been continuous communication between all parties that are helping to process that.
