## **Project Background**

- Location Magothy River on Bayberry Drive
- Approximately 57-acre park area which includes a cartop launch, natural areas, picnic area, historic residence, and approximately 800 Linear Feet of shoreline used for fishing and recreation.
- Erosion of ±2 feet/year that has resulted in safety concerns at the edge of the bank.
- The site does not comply with ADA Accessibility Requirements
- Design initiated in 2017 and presented to community on 2-4-2021. The initial design's excessive habitat impacts prevented regulatory approval.
- Redesign initiated in 2022.









## Spriggs Farm Park Existing Conditions - West Shoreline

- Steep, eroded 15 feet high banks
- Eroded shoreline compromises integrity of safety fence

## Spriggs Farm Park Existing Conditions - East Shoreline

- Sandy beach backed by eroded bank with exposed tree roots
- Eroding edge of marsh











#### Spriggs Farm Park Existing Conditions - Access Path

- Narrow, eroding path with exposed tree roots
- Grades too steep for ADA compliant access







## Kayak Launch


- Install stone groins to act as containment for the sand
- Gentle 10(H):1(V) Slope for safe access
- Loading/unloading area for increased accessibility

Sand for Kayak Launch




#### **Accessibility Improvements**

20 feet of Flat Landing for Loading/Unloading

- Ramped path with handrailing and intermittent landing areas
- ADA- compliant parking will be added in the next design phase





### **Construction Access**

- Construction entrance across from 896 Bayberry Drive
- Construction vehicle traffic
  - On-site placement of surplus material to reduce traffic
- Coordination with bus schedule
