

Anne Arundel County - Special Events Resource Matrix

All special events are subject to:

- (1) the guiding principles of incident management as outlined in the FEMA National Incident Management System (NIMS) doctrine.
- (2) variations in recommended and/or required resources based on the risk assessment of each event, which includes the type of event, purpose, location, duration, anticipated crowd size, weather conditions, and other safety and/or security factors deemed appropriate by public safety officials.

Any special events greater than 2,500 in a single setting may be subject to unified public safety command and control as the event dictates, which may include costs for any additional on-site personnel.
