I do not want the neighborhood opened up to thru traffic and increasing the possibility for crime, car congestion, accidents, etc. Any new construction should add value to the area, instead of decreasing home values and disrupting the flow of an established neighborhood.

  HARBOR ALREADY HAS INFRASTRUCTURE. THE LAST THING HOSPITAL DRIVE NEEDS IS MORE
  SPEEDING CARS TO HIT OUR KIDS. ITS ASSANINE THE WAY YOU KEEP COMING FOR US.

MCP presently supplements several state & county environmental initiatives & provides ecological benefits at no cost to the county in its current state.
