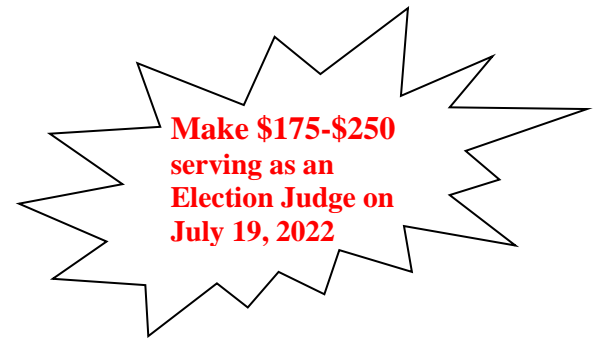

Dear Voter:

One of the responsibilities of the Anne Arundel County Board of Elections is to appoint Election Judges to staff the Anne Arundel County polling places for the 2022 Gubernatorial Elections. We are recruiting Election Judges to fill our vacant positions.

Election Judges are being recruited to work Primary Election Early Voting Days, July 7th thru June 14th, 2022 and the General Election Early Voting Days, October 27th thru November 3rd, 2022 on a first-come, first-served basis. As there are only seven early voting sites in the county, space is very limited. Election Judge positions are also being recruited for the Primary Election Day, July 19, 2022 and the General Election Day, November 8, 2022.

**An application is required for each election cycle. All judges, including returning judges, must complete the application. No experience is required. We will provide comprehensive training. Under Maryland Law, Election Judges must train for both the Primary and General Elections, if the State Administrator considers it necessary.**

**DUTIES:** Election Judges play a very important role in the electoral process. They are responsible for administering voting procedures in polling places while ensuring a fair and equitable election for all eligible voters. Duties may include checking-in voters, assisting voters with using the voting equipment, overseeing all election procedures throughout the polling place and setting up and breaking down the polling place before and after voting hours.

Additionally, Election Judges must make sure that qualified voters who are properly registered are able to cast their vote in a safe and secure environment. Election Judges represent the entire electoral process and may be the only people a voter has contact with when exercising their right to vote. Therefore, the Election Judge must be reliable, courteous, and able to follow procedures exactly and, above all, possess good judgment.

**MINIMUM QUALIFICATIONS:**

1. Be a registered voter in the State of Maryland
2. Must be able to speak, read, and write the English language;
3. Physically and mentally able to work at least a 12 to 15 hour day;
4. Be able to lift at least 25 pounds;
5. Be able to sit and/or stand for an extended period; and
6. Be able to attend a three hour hands-on training class. Training is required for **BOTH** the primary and the general elections.

You **CANNOT** be an Election Judge **AND** be a candidate or currently hold a public and political office, including state and county political party central committees; Chairman, campaign manager, or treasurer for a political or candidate committee; or engage in any partisan or political activity while on duty.

Knowledge of computers is not mandatory, but preferred. Bilingual speakers are encouraged to apply.

All Election Judges are compensated for their services for Early Voting, Election Day, and attending mandatory training classes. Chief Judges are paid \$250 per day. Voting Operation Judges and Provisional Judges are paid \$175 per day. All Election Judges shall attend a mandatory training class. All Election Judges shall be paid \$35 per training class. To be paid for the training class, Election Judges **must** work on Election Day. All election judges can **EXPECT PAYMENT FOUR TO SIX WEEKS AFTER THE ELECTION.**
