RE: Bill 100-20: An Ordinance concerning: Current Expense Budget – Downs Amphitheater Improvements – Supplementary Appropriations – Capital Budget and Program – Fund Transfer

Dear Mr. Pittman:

The Planning Advisory Board (PAB) is a citizen advisory board created by §532 of the Anne Arundel County Charter. Under § 533 of the Charter, the PAB is charged with recommending the list of capital projects, along with their estimated costs, to be implemented by the County. Also under § 533, the PAB considers and transmits advisory recommendations for amendments to the Capital Budget to the County Executive through the course of the year.

The PAB met on November 18, 2020 and received an overview of Bill 100-20 from Budget Office staff. This Ordinance is a proposal for the purpose of making supplementary appropriations from unanticipated revenues by transferring certain appropriations of funds between the Road Resurfacing (Project No. H478600), B & A Ranger Station Rehab (Project No. P564900), and Downs Park Amphitheater (Project No. P573400) capital projects. The result is making supplementary appropriations from unanticipated grant revenue to the current expense budget and transferring funds to realign certain capital appropriations between projects in the Capital Budget for the next fiscal year ending June 30, 2021.

Following the presentation and discussion among the members of the PAB, the Board unanimously voted 6-0 to offer an advisory recommendation of approval of Bill 100-20.
