Section 532 of the Anne Arundel County Charter has established the Planning Advisory Board (PAB). Section 532 (b) establishes that the PAB shall make advisory recommendations to the Planning and Zoning Officer and the County Council relating to various matters including Master Plans. Among those documents reviewed, and for which advisory recommendations are rendered by the PAB, is the *Master Plan for Water Supply and Sewerage Systems*.

On October 14, 2020, the PAB met and was presented information regarding Bill No. 77-20 from the Office of Planning and Zoning which proposes one map amendment to the 2017 Master Plan for Water Supply and Sewerage Systems. At such time, the PAB also offered time for public testimony. No testimony was received by the PAB.

Following the County staff presentation, public hearing and discussion among the members of the PAB, the Board voted unanimously 5-0 to provide an advisory recommendation of approval of Bill 77-20 permitting the amendment to the *Master Plan for Water Supply and Sewerage Systems*.

The PAB appreciates the opportunity to provide you with our advisory recommendation of approval of Bill 77-20. Understanding the importance of the Plan in implementing the

recommendations of the *General Development Plan*, the Board looks forward to our continued involvement in the water and sewer planning process.
