PUBLIC TESTIMONY



- Individuals will be given 3 minutes to speak.
- Individuals speaking on behalf of Community Associations (with an already submitted verified letter) will be given 5 minutes to speak.
- Legal representatives will be given 3 minutes per each client represented.

Rules and Procedures

- Oral Testimonies will be *audio only*. Speakers will not be able to share their screen.
- Only speakers that signed up before the 5:00 pm January 4th deadline will be able to provide testimony to the board.
- The Speaker List will be shown on screen. Speakers will be unmuted when they are next up to speak.

Rules and Procedures

- The speaker list will feature the speaker name and time allotment.
- When your name is called to speak a pop-up window will appear to unmute your audio. Click unmute and begin your testimony and state your name for the record.
- A 30 Second warning will be given if a speaker nears the end of their time.
- If a speaker is called and is not available, their slot will be placed at the end of the speaker list.

Meeting Decorum

- Please be polite. Any cursing, profane and inappropriate language or insults will result in a forfeiture of a speaker's time. Refrain from political discussions.
- This meeting is to provide oral testimonies only. There will be no debates or questions of the PAB members.
- Testimonies should be focused on Plan2040. Please refrain from discussing issues that are related to other County processes.
