10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

15 **TITLE 7. SPECIAL COMMUNITY BENEFIT DISTRICTS, SHORE EROSION**
16 **CONTROL DISTRICTS, AND WATERWAYS IMPROVEMENT DISTRICTS**

18 **4-7-204. Districts established.**

20 (qq) **North Beach Park Special Community Benefit District.**

22 (1) The limits of the North Beach Park Special Community Benefit District are the
23 subdivision known as North Beach Park as shown on the plats recorded among the plat

4 (2) The district is established for the purpose of mosquito control; [and] payment of
5 the salary, expenses, and allowances for a special police officer; AND MAINTENANCE AND
6 IMPROVEMENT OF COMMUNITY-OWNED PROPERTY.

7
8 (3) THE HOLLAND POINT CITIZENS ASSOCIATION, INC., A CIVIC OR COMMUNITY
9 ASSOCIATION THAT MEETS THE CRITERIA SET FORTH IN THE ANNE ARUNDEL COUNTY CODE,
10 § 4-7-101(D), SHALL BE RESPONSIBLE FOR ADMINISTERING THE NORTH BEACH PARK SPECIAL
11 COMMUNITY BENEFIT DISTRICT ASSESSMENTS IN FURTHERANCE OF THE PURPOSES OF THE
12 DISTRICT.

14 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days
15 from the date it becomes law.






