A BILL ENTITLED

1 AN ORDINANCE concerning: Subdivision and Development and Zoning – Cluster
2 Development

4 FOR the purpose of defining “cluster development”; requiring cluster development to
5 include landscaped screening and buffer areas; exempting applications for cluster
6 development made before a certain date from certain requirements; and generally
7 relating to subdivision and development and zoning.

9 *That § 18-1-101(31) of the Anne Arundel County Code (2005, as amended) is hereby*
10 *repealed.*

13 *respectively; and 18-1-101 (32) through (164), respectively, of the Anne Arundel County*
14 *Code (2005, as amended) are hereby renumbered to be §§17-1-101(17) through (102),*
15 *respectively; and 18-1-101(31) through (163), respectively.*

20 **ARTICLE 17. SUBDIVISION AND DEVELOPMENT**

22 **TITLE 1. DEFINITIONS**

23
24 **17-1-101 Definitions.**

25
26 Unless defined in this article, the Natural Resources Article of the State Code, or
27 COMAR, the definitions of words defined elsewhere in this Code apply in this article. The
28 following words have the meanings indicated:

30 (16) "CLUSTER DEVELOPMENT" MEANS A RESIDENTIAL DEVELOPMENT IN
31 WHICH DWELLING UNITS ARE CONCENTRATED IN A SELECTED AREA OR SELECTED AREAS
32 OF THE DEVELOPMENT THROUGH FLEXIBILITY IN LOT SIZE DESIGN, SO AS TO PRESERVE
33 AND PROTECT NATURAL FEATURES, CONSERVE FOREST, PROVIDE OPEN SPACE FOR
34 PASSIVE AND ACTIVE RECREATION, AND INTEGRATE ENVIRONMENTAL SITE
35 DESIGN, WITHOUT AN INCREASE IN OVERALL DENSITY.

37 **TITLE 2. GENERAL PROVISIONS**

39 **17-2-101. Scope; applicability.**

40
41 **(b) Applicability to pending and future proceedings.** Subject to the grandfathering
42 provisions of COMAR Title 27, this article applies to all pending and future proceedings
43 and actions of any board, department, or agency empowered to decide applications under
44 this Code, except that:

45
46 (14) the following shall be governed by the law as it existed prior to January 9,
47 2020:

1 (i) an application for approval of a sketch plan, final plan, final infrastructure
2 construction plan, preliminary plan, or site development plan, and any building or grading
3 permits associated with these plans, filed on or before December 15, 2019;
4

5 (ii) applications for building and grading permits that are not associated with a
6 final plan or site development plan filed on or before December 15, 2019;
7

8 (iii) revisions to the plans and permits referenced in subparagraphs (i) and (ii)
9 that do not materially alter the proposed or actual limits of disturbance; and
10

11 (iv) an application for a special exception filed on or before December 15, 2019
12 and all applications associated with the special exception; [[and]]
13

14 (15) an application for sketch plan approval, final plan approval, preliminary plan
15 approval, or approval of a building or grading permit associated with a BRAC Mixed Use
16 Development plan that was filed before June 27, 2022 shall be governed by the law as it
17 existed prior to June 27, 2022[.]; AND
18

19 (16) AN APPLICATION FOR APPROVAL OF A SKETCH PLAN OR FINAL PLAN FOR A
20 CLUSTER DEVELOPMENT, AND ANY BUILDING PERMIT, GRADING PERMIT, OR OTHER
21 APPLICATION ASSOCIATED WITH A CLUSTER DEVELOPMENT, FILED BEFORE THE
22 EFFECTIVE DATE OF BILL NO. 73-22 SHALL BE GOVERNED BY THE LAW AS IT EXISTED
23 PRIOR TO THE EFFECTIVE DATE OF BILL NO. 73-22.

25 TITLE 3. SUBDIVISION

26 17-3-502. Lot design criteria.

29 (b) **Building envelope; cluster development.** A residential lot shall be of sufficient
30 size to have a building envelope UNENCUMBERED BY EASEMENTS OR RESTRICTIONS THAT
31 SUBSTANTIALLY RESTRICT THE USE OF THE BUILDING ENVELOPE. Residential dwelling
32 units on residential lots shall be clustered to the maximum extent practicable as determined
33 by the Office of Planning and Zoning. In determining the extent to which clustering will
34 be required for a minor subdivision or subdivision of lots shown on a previously recorded
35 plat, the Planning and Zoning Officer shall evaluate the development patterns and lot sizes
36 of adjoining properties and approve development that does not substantially alter the
37 character of the neighborhood. [[The lots shall be of sufficient size to have a building
38 envelope unencumbered by easements or restrictions that substantially restrict the use of
39 the building envelope.]] CLUSTER DEVELOPMENT SHALL INCLUDE LANDSCAPED
40 SCREENING AND BUFFER AREAS OF SUFFICIENT WIDTH ALONG ADJACENT ROADS,
41 EXCLUDING LOCAL ROADS, THAT HAVE A WIDTH OF 25 FEET, ALONG ADJACENT, NON-
42 LOCAL ROADS AND ADJOINING PROPERTIES THAT ARE NOT A PART OF THE
43 DEVELOPMENT.

45 SECTION 4. *And be it further enacted,* That all references in this Ordinance to “the
46 effective date of Bill No. 73-22”, or words to that effect, shall upon codification, be
47 replaced with the actual date on which this Ordinance takes effect under Section 307 of the
48 County Charter as Certified by the Administrative Officer to the County Council.

50 SECTION 4. 5. *And be it further enacted,* That this Ordinance shall take effect 45 days
51 from the date it becomes law.
