A BILL ENTITLED

1 AN ORDINANCE concerning: Tax Levies – Village South at Waugh Chapel Special
2 Taxing District

4 FOR the purpose of levying and imposing the tax rates for the Village South at Waugh
5 Chapel Special Taxing District required by the County Budget for Fiscal Year 2019.
6

7 WHEREAS, by Bill No. 19-10, the County Council established the Village South
8 at Waugh Chapel Special Taxing District and authorized the issuance and sale of
9 certain special obligation bonds to fund certain infrastructure improvements
10 relating to the development and utilization of the land within the Village South at
11 Waugh Chapel Special Taxing District, all pursuant to Article 24, § 9-1301 of the
12 Annotated Code of Maryland and §§ 4-8-101, et seq., of the Anne Arundel
13 County Code (2005, as amended) (together, the “Act”);

15 WHEREAS, by Bill No. 19-10, the County is required to determine the special
16 tax requirement applicable to such district and to levy the special tax for the Fiscal
17 Year 2019; and


19 WHEREAS, for Fiscal Year 2019, it has been determined that the debt service on
20 the special obligation bonds and other costs related to issuance of such bonds or to
21 the administration of the district will be paid from sources other than the proceeds
22 of the special taxes; now, therefore,

24 SECTION 1. *Be it enacted by the County Council of Anne Arundel County,*
25 *Maryland,* That a special tax for the taxable year beginning July 1, 2018, and ending on
26 June 30, 2019, is hereby levied and imposed pursuant to the Act and other applicable
27 authority in the Village South at Waugh Chapel Special Taxing District for all taxable
28 parcels of whatever classification at the rate of \$0.00.

1 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect on July
2 1, 2018.
