4 FOR the purpose of repealing the designation of school impact fee districts created by Bill
5 No. 87-18; designating the school impact fee districts ~~as they existed prior to the~~
6 ~~effective date of Bill No. 87-18~~; adopting the school impact fee district ~~maps as they~~
7 ~~existed prior to the effective date of Bill No. 87-18 as the school impact fee district~~
8 ~~maps~~ map dated June 15, 1992; providing for the allocation of school impact fees paid
9 between November 18, 2018, the effective date of Bill No. 87-18, and this Ordinance;
10 making certain technical changes; making this Ordinance an emergency measure; and

17 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
18 That Section of the Anne Arundel County Code (2005, as amended)(and as amended by
19 Bill No. 87-18) read as follows:

21 **ARTICLE 17. SUBDIVISION AND DEVELOPMENT**

TITLE 11. FEES AND SECURITY

17-11-209. Use of funds.

(c) Districts.

[(1)] The school impact fee districts shall BE AS SHOWN ON THE SCHOOL IMPACT FEE DISTRICTS MAP, AND THE [be based on the high school feeder districts established by the Board of Education:

(i) district one shall be the Annapolis High School, Southern High School, South River High School, and Crofton Area High School feeder districts;

(ii) district two shall be the Arundel High School, Meade High School, and Old Mill West High School feeder districts;

(iii) district three shall be the Glen Burnie High School, Old Mill High East High School, and North County High School feeder districts; and

(iv) district four shall be the Severna Park High School, Broadneck High School, Chesapeake High School and Northeast High School feeder districts.

(2) The] transportation impact fee districts shall be as shown on the transportation impact fee districts maps as adopted by the County Council. The SCHOOL IMPACT FEE DISTRICT MAP PREPARED BY THE OFFICE OF PLANNING AND ZONING AND DATED ~~MAY 1, 1992~~ JUNE 15, 1992, AND THE transportation impact fee district maps prepared by the Office of Planning and Zoning and dated July 20, 1987, and May 8, 2009, are adopted as the [transportation] DEVELOPMENT impact fee district maps.

[(3)] The public safety impact fee district shall be the County as a whole.


SECTION 2. *And be it further enacted*, That the school impact fee districts map prepared by the Office of Planning and Zoning dated ~~May 1, 1992, attached as Exhibit A, June 15, 1992, attached as Exhibit A-1~~ is hereby adopted.

SECTION 3. *And be it further enacted*, That, upon the effective date of this Ordinance, any school impact fees attributed to the four school impact fee districts created by Bill No. 87-18 shall be allocated to the school impact fee district applicable to the development for which the fees were paid, as shown on the school impact fee district map prepared by the Office of Planning and Zoning and dated ~~May 1, 1992, attached as Exhibit A June 15, 1992, attached as Exhibit A-1.~~


SECTION 4. *And be it further enacted*, That this Ordinance is hereby declared to be an emergency ordinance and necessary for the immediate preservation of the public peace, health, safety, welfare, and property, and being passed by the affirmative vote of a minimum of five members of the County Council, the same shall take effect from the date it becomes law.

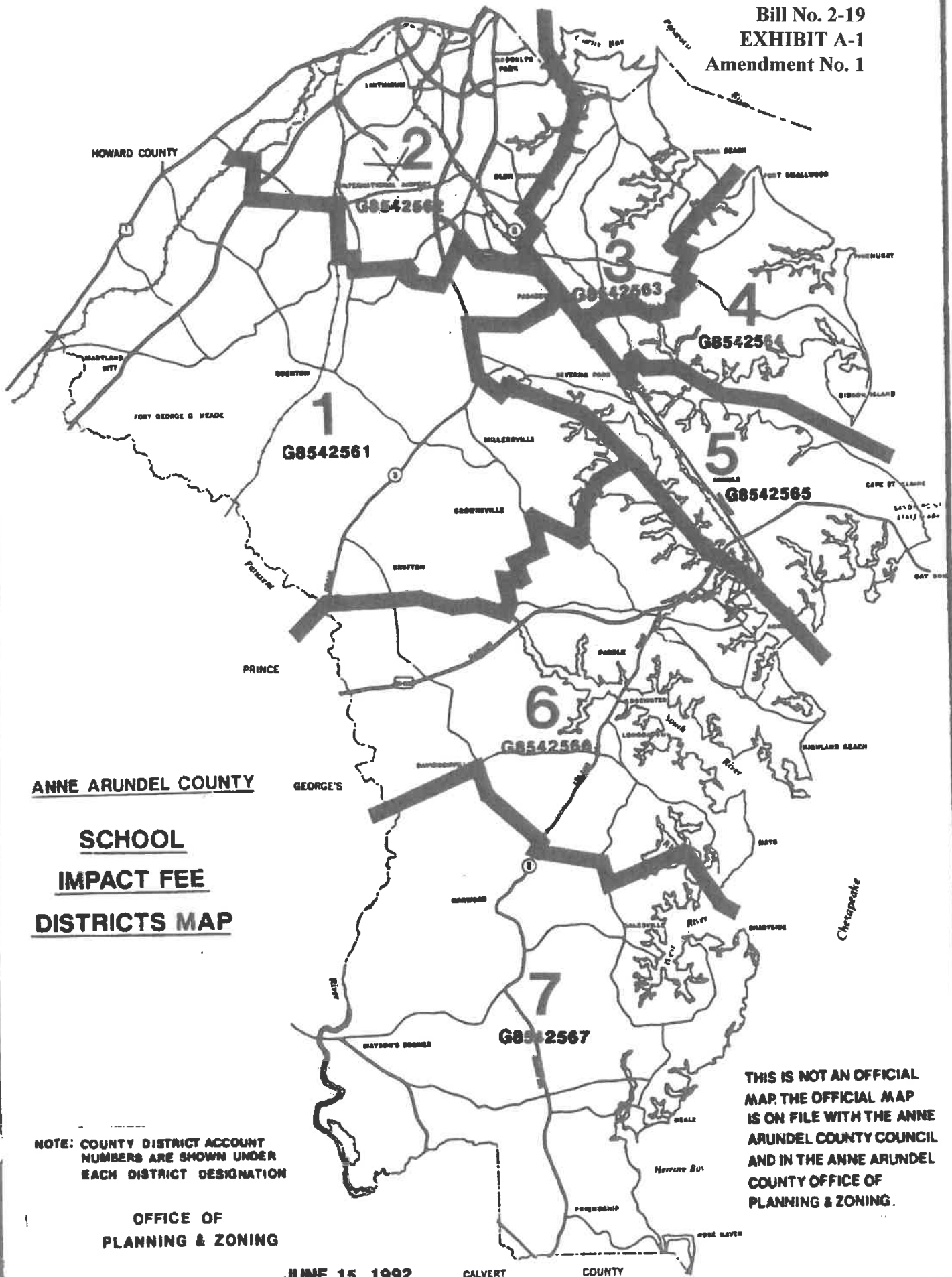
