4 FOR the purpose of adopting new standards for determining the boundaries of school
5 impact fee districts; and generally relating to subdivision and development.

7 BY repealing and reenacting, with amendments: § 17-11-209(c)
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

13 **ARTICLE 17. SUBDIVISION AND DEVELOPMENT**

14 **TITLE 11. FEES AND SECURITY**

15 **17-11-209. Use of funds.**

16 **(c) Districts.**

17 (1) The school impact fee districts shall [be as shown on the school impact fee
18 districts map, and the] BE BASED ON THE FOLLOWING HIGH SCHOOL FEEDER DISTRICTS AS
19 ESTABLISHED BY THE BOARD OF EDUCATION:

1 (I) DISTRICT ONE SHALL BE THE ANNAPOLIS HIGH SCHOOL, SOUTHERN HIGH
2 SCHOOL, SOUTH RIVER HIGH SCHOOL, AND CROFTON HIGH SCHOOL FEEDER DISTRICTS;

4 (II) DISTRICT TWO SHALL BE THE ARUNDEL HIGH SCHOOL, MEADE HIGH
5 SCHOOL, AND OLD MILL WEST HIGH SCHOOL FEEDER DISTRICTS;

7 (III) DISTRICT THREE SHALL BE THE GLEN BURNIE HIGH SCHOOL, OLD MILL
8 EAST HIGH SCHOOL, AND NORTH COUNTY HIGH SCHOOL FEEDER DISTRICTS; AND
9

10 (IV) DISTRICT FOUR SHALL BE THE SEVERNA PARK HIGH SCHOOL, BROADNECK
11 HIGH SCHOOL, CHESAPEAKE HIGH SCHOOL AND NORTHEAST HIGH SCHOOL FEEDER
12 DISTRICTS.
13

14 (2) THE transportation impact fee districts shall be as shown on the transportation
15 impact fee districts maps as adopted by the County Council. The [school impact fee district
16 map prepared by the Office of Planning and Zoning and dated May 1, 1992, and the]
17 transportation impact fee district maps prepared by the Office of Planning and Zoning and
18 dated July 20, 1987, and May 8, 2009, are adopted as the [development] TRANSPORTATION
19 impact fee district maps.

21 (3) The public safety impact fee district shall be the County as a whole.
22

23 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days
24 from the date it becomes law.


