1 AN ORDINANCE concerning: Branches of County Government – Judicial Branch –  
2 Orphans’ Court – Judges’ Salary

4 FOR the purpose of setting the annual compensation of Orphans’ Court Judges; and  
5 generally relating to the Orphans’ Court.

7 BY adding: § 2-3-202  
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
11 *That Anne Arundel County Code (2005, as amended) read as follows:*

13 **ARTICLE 2. BRANCHES OF COUNTY GOVERNMENT**

15 **TITLE 3. JUDICIAL BRANCH**

16  
17 **2-3-202. Compensation.**

18  
19 (A) **Judge.** EXCEPT AS PROVIDED IN SUBSECTION (B), EACH JUDGE OF THE ORPHANS’  
20 COURT IS ENTITLED TO AN ANNUAL SALARY OF \$39,000.

21  
22 (B) **Chief Judge.** THE CHIEF JUDGE OF THE ORPHANS’ COURT IS ENTITLED TO AN  
23 ANNUAL SALARY OF \$39,500.

24  
25 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days  
26 from the date it becomes law.


