Budget proposal includes no new taxes and first surplus in a decade

The proposed County budget for Fiscal Year 2017 includes no new taxes, a projected surplus, salary increases for all County employees and funding to repair roads and bridges.

There are many ways you can learn more about the proposal, which is currently under review by the County Council.

First, you can watch the speech by County Executive Steven R. Schuh and the slide presentation outlining the budget highlights.

The County Council will hold more than a dozen meetings to review the budget, as well as two public hearings at North County High School on May 9 and Annapolis High School on May 12.

Last year, we set out an agenda to help our County reach its full potential. We began working to change the policies and culture of Anne Arundel County. And we are succeeding. There were some disagreements along the way, but, in the end, we worked together to change fundamentally the direction of our County for the better.

The vision of our Administration is for Anne Arundel County to be the best place to live, work, and start a business in the State of Maryland. In furtherance of that vision, each of us is working to implement our basic five-point plan for County Government.

Our goals are to: Reduce taxes and fees, improve education by accelerating development of smaller neighborhood schools, improve public safety infrastructure and staffing, make government more efficient and customer-friendly, and clean up our waterways.


Our recently proposed budget continues to make that vision a reality.

The budget reflects a nearly 1 percent cut in property tax rates due to our revenue cap, building on our historic tax and fee cuts last year. The new rate cut represents a 5.5 million dollar tax cut to property owners.

The budget also includes a 2 percent salary increase for all employees and 3 percent for public safety, as well as construction funding for a new Crofton High School at long last. We also make key investments to repair roads and bridges, continue our stormwater improvement projects and improve our trails and public water access.

Together these initiatives will make Anne Arundel County the best place to live, work and start a business in Maryland.
