Employees who achieve a satisfactory performance review shall receive an increase in pay, not to exceed maximum of grade, in accordance with the Memorandum of Agreement between Anne Arundel County and the Fraternal Order of Anne Arundel Detention Center Officers and Personnel, Inc., effective July 1, 2020; only once every 12 months.

Hourly rate is determined by dividing annual pay by 2080 hours, rounded to 3 decimal places.
