This pay schedule applies to employees in the classification of Deputy Sheriff I (S1) and Deputy Sheriff Corporal (S1A).

Implements negotiated pay schedule effective on the pay period beginning July 11, 2019.

Implements across the board adjustment by adding 3% to each step of the July 11, 2019 pay schedule effective the first full pay period on or after January 7, 2020.

Employees who achieve a satisfactory performance review shall receive a merit pay advancement by advancing one step on the pay schedule, not to exceed maximum for grade; only once every 12 months.

Hourly rate determined by dividing annual pay by 2080 hours, rounded to 3 decimal places.
