



“Stop POollution in its Tracks” Campaign – August 24th Meeting Highlights Summary

MEETING HIGHLIGHTS:

Who We Are –

- **The Anne Arundel County Bureau of Watershed Protection & Restoration (BWPR)** is responsible for reducing pollutant loads to the Chesapeake Bay. Implementing a social behavior change campaign focused on encouraging residents to help “Stop POollution in its Tracks” aims to contribute to local clean water efforts. This campaign is funded by the Watershed Protection & Restoration Fee, which comes from local property taxes.
- **The Anne Arundel County Watershed Stewards Academy (WSA)** builds capacity in the county by providing resources and training Master Watershed Stewards to help neighbors reduce pollution in our local creeks and rivers.

Why focus on pet waste?

- **It pollutes our waterways** – bacteria from pet waste left on the ground is carried away by rain into our streams.
- **It attracts pests** – pet waste attracts rats and mosquitoes that spread disease.
- **It is unsightly** – pet waste detracts from our neighborhoods and natural areas.
- **Anne Arundel County has a TMDL** – we are required by the Clean Water Act to reduce bacteria in our waterways. This requirement is called a Total Maximum Daily Load (TMDL), or “pollution diet.”

What is the contribution of pet waste to bacteria in our local waterways?

- Anne Arundel County currently has 19 sub-watersheds with associated TMDLs for bacteria pollutants, including fecal coliform, Enterococci, and E. Coli.
- According to MDE bacteria source tracking (BST) data...
 - **Pet waste is the #1 contributor of bacteria loads in Anne Arundel County’s waterways, accounting for over 45% of the total annual bacteria load.**

What is Anne Arundel County doing about this problem?

- BWPR is working with Anne Arundel Community College to sample and monitor targeted waterways for bacteria impairment, including a site in your community!
- BWPR has also partnered with WSA to implement an education and outreach campaign encouraging dog owners in Anne Arundel County to “scoop every time there’s poop.” We are pilot testing the campaign messaging and materials with both the Avalon Shores community and the Manhattan Beach community to assess effectiveness before implementing Countywide.

What are the goals of the “Stop POollution in its Tracks” Campaign?

- **Encourage** Anne Arundel County residents to pick up pet waste and **educate** them as to why it is important.
- **Partner** with community representatives to distribute outreach materials and **normalize** scooping every time there’s poop.
- Ultimately, **minimize** the contribution of pet waste to the overall bacteria pollutant load in the Chesapeake Bay.

What resources are available through this campaign?

- At www.AAWSA.org/pick-up-pet-waste/, you can find tools and resources to take immediate action, including a virtual pledge to “scoop the poop,” downloadable/printable outreach materials, and guidance for engaging neighbors in focused conversations.
- County residents that would like to participate more actively in the behavior change campaign are eligible to receive a FREE “Stop POollution” Campaign Kit, along with a brief training and collaboration with Bureau staff to share the messaging in a way that works for you and your community.

What’s Next, and what can you do NOW?

- Our team will continue to coordinate with MBHOA to join the community for an in-person event this Fall to follow this virtual meeting.
- The HOA has expressed interest in seeing additional pet waste stations managed on the western side of the community, as well as along the nearby B&A Trail. Our Bureau will coordinate with the HOA to organize the installation of additional stations, as well as work with the Anne Arundel County Department of Recreation & Parks to inquire about additional pet waste stations being placed along the trail.
